SENATE BILL NO. 2325

AN ACT MAKING AN ADDITIONAL APPROPRIATION OF STATE GENERAL 1 FUNDS TO DEFRAY THE EXPENSES OF THE STATE VETERANS AFFAIRS BOARD 2 3 FOR PRIOR FISCAL YEARS AND FISCAL YEAR 2005. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 4 SECTION 1. In addition to all other sums heretofore 5 appropriated, the following sum, or so much thereof as may be 6 necessary, is hereby appropriated out of any money in the State 7 8 General Fund not otherwise appropriated, to defray the expenses of the State Veterans Affairs Board, for the fiscal year ending 9 June 30, 2005 \$ 2,362,826.74. 10

SECTION 2. This additional appropriation is made for the purpose of preventing a deficit which would otherwise occur.

13 SECTION 3. With the funds appropriated herein, the State
14 Veterans Affairs Board is authorized to make payment for expenses
15 incurred during previous fiscal years as follows:
