8	SECTION 1. (1) The State of Mississippi may sell and convey

11	University of Mississippi pursuant to the act of the United States
12	Congress dated June 30, 1894, Chapter 110, 28 Stat. 94 (1894),
13	such lands being more particularly described as follows:

21	(2) The property described in subsection (1) of this section
22	shall be sold for not less than the current fair market value as
23	determined by the averaging of at least two (2) appraisals by
24	qualified appraisers who shall be selected by the Bureau of
25	Building, Grounds and Real Property Management, Department of
26	Finance and Administration.
27	(3) Proceeds from the sale of the property described in
28	subsection (1) of this section shall be deposited into an

- 30 principal of the fund shall remain inviolate and shall be invested
