6	<b>SECTION 1.</b> (1) Any owner of a motor vehicle who is a
7	resident of this state, upon payment of the road and bridge
8	privilege taxes, ad valorem taxes and registration fees as
9	prescribed by law for private carriers of passengers, pickup
10	trucks and other noncommercial motor vehicles, and upon payment of
11	an additional fee in the amount provided in subsection (3) of this
12	section, shall be issued a distinctive license tag for each motor
13	vehicle registered in his name identifying such person as a
14	supporter of the Mississippi Prehospital Professionals
15	Association. The distinctive license tags so issued shall be of
16	such color and design as the State Tax Commission, with the advice
