1 2 3 4 5 6 7 8 9	AN ACT TO CREATE A CERTIFICATION PROGRAM FOR TAX COLLECTORS, TAX ASSESSORS/COLLECTORS AND THEIR DEPUTIES; TO REQUIRE COUNTIES TO HAVE A CERTIFIED COLLECTOR; TO REQUIRE REIMBURSEMENT OF MILEAGE AND EXPENSES WHEN ANY TAX COLLECTOR, TAX ASSESSOR/COLLECTOR OR DEPUTY TRAVEL OUTSIDE HIS COUNTY TO ATTEND A CERTIFIED COLLECTION SEMINAR; TO REQUIRE ADDITIONAL COMPENSATION TO BE PAID TO ANY TAX COLLECTOR, TAX ASSESSOR/COLLECTOR OR DEPUTY WHO SUCCESSFULLY COMPLETES CERTAIN LEVELS OF CERTIFICATION; TO CREATE AN ADVISORY BOARD TO OVERSEE THE MISSISSIPPI COLLECTORS EDUCATION AND CERTIFICATION PROGRAM; AND FOR RELATED PURPOSES.
11	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
12	SECTION 1. (1) (a) The Office of the State Auditor shall
13	promulgate rules and regulations setting forth the minimum
14	requirements for which collectors, assessors/collectors or their
15	deputies may attain certification as a collector of state, county
16	or municipal revenue. The Office of the State Auditor, in
17	cooperation with the Center for Governmental Training and
18	Technology within the Mississippi State University Extension
19	Service, shall establish and conduct such education and training
20	programs as may be appropriate for such persons to attain the
21	certification.
22	(b) Counties having not more than fifteen thousand
23	(15,000) parcels of real property shall have at least one (1)
24	certified collector, and counties having more than fifteen
25	thousand (15,000) parcels of real property shall have at least two
26	(2) certified collectors.

(2) (a) When any tax collector, tax assessor/collector or

his deputy travel outside their county to attend a certified

collection school, seminar or workshop approved by the Office of

the State Auditor, such person shall receive as reimbursement of

expenses of such travel the same mileage and actual and necessary

- 32 expenses for food, lodging and travel by public carrier or private
- 33 motor vehicles as allowed under Section 25-3-41. However, mileage
- 34 shall not be authorized when such travel is done by a motor
- 35 vehicle owned by the county.
- 36 (b) The county board of supervisors shall reimburse the
- 37 tax collector, tax assessor/collector or his deputy for reasonable
- 38 and necessary expenses sustained in attending annual conferences,
- 39 regional conferences, schools and seminars. The Office of the
- 40 State Auditor shall have the authority to prescribe forms and to

- 82 (c) One (1) member to be appointed by the State Auditor
- 83 and approved by the Mississippi Assessors and Collectors

- 85 (d) One (1) member appointed by the President of the
- 86 Mississippi Assessors and Collectors Association; and
- 87 (e) Two (2) members representing the Center for
- 88 Governmental Training and Technology.
- 89 **SECTION 2.** The Attorney General of the State of Mississippi
- 90 shall submit this act, immediately upon approval by the Governor,
- 91 or upon approval by the Legislature subsequent to a veto, to the
- 92 Attorney General of the United States or to the United States
- 93 District Court for the District of Columbia in accordance with the
- 94 provisions of the Voting Rights Act of 1965, as amended and
- 95 extended.
- 96 **SECTION 3.** This act shall take effect and be in force from
- 97 and after the date it is effectuated under Section 5 of the Voting

- 98 Rights Act of 1965, as amended and extended, or October 1, 2005,
- 99 whichever occurs later.
