SENATE BILL NO. 2876

1	AN ACT TO AMEND SECTION 27-19-56.37, MISSISSIPPI CODE OF
2	1972, TO PROVIDE THAT A PORTION OF THE FEE FOR A DISTINCTIVE MOTOR
3	VEHICLE LICENSE TAG IDENTIFYING A PERSON AS A CONSTABLE SHALL BE
4	DISTRIBUTED TO THE MISSISSIPPI CONSTABLES ASSOCIATION; AND FOR
5	RELATED PURPOSES.

- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 7 **SECTION 1.** Section 27-19-56.37, Mississippi Code of 1972, is
- 8 amended as follows:
- 9 27-19-56.37. (1) Any owner of a motor vehicle who is a duly
- 10 elected constable, upon payment of the road and bridge privilege
- 11 taxes, ad valorem taxes and registration fees as prescribed by law
- 12 for private carriers of passengers, pickup trucks and other
- 13 noncommercial motor vehicles, and upon payment of an additional
- 14 fee in the amount provided in subsection (3) of this section,
- 15 shall be issued a distinctive license tag for any motor vehicle
- 16 registered in his name identifying the person as a constable. The
- 17 distinctive license tags so issued shall be of such color and
- 18 design as the State Tax Commission may prescribe and shall consist
- 19 of such letters or numbers, or both, as may be necessary to
- 20 distinguish each license tag.
- 21 (2) Application for the distinctive license tags authorized
- $22\,$ $\,$ by this section shall be made to the county tax collector on forms
- 23 prescribed by the State Tax Commission. The application and the
- 24 additional fee imposed under subsection (3) of this section, less
- 25 Two Dollars (\$2.00) thereof to be retained by the tax collector,
- 26 shall be remitted to the State Tax Commission on a monthly basis
- 27 as prescribed by the commission. The portion of the additional

- 28 fee retained by the tax collector shall be deposited into the
- 29 county general fund.
- 30 (3) Beginning with any registration year commencing on or
- 31 after July 1, 2002, any person applying for a distinctive license
- 32 tag under this section shall pay an additional fee in the amount
- 33 of Thirty Dollars (\$30.00) for each distinctive license tag
- 34 applied for under this section, which shall be in addition to all
- 35 other taxes and fees. The additional fee paid shall be for a
- 36 period of time to run concurrent with the vehicle's established
- 37 license tag year. The additional fee is due and payable at the
- 38 time the original application is made for a distinctive license
- 39 tag under this section and thereafter annually at the time of
- 40 renewal registration as long as the owner retains the distinctive
- 41 license tag. If the owner does not wish to retain the distinctive
- 42 license tag, he must surrender it to the local county tax
- 43 collector.
- 44 (4) The State Tax Commission shall deposit all fees into the
- 45 State Treasury on the day collected. At the end of each month,
- 46 the State Tax Commission shall certify to the State Treasurer the
- 47 total fees collected under this section from the issuance of the
- 48 distinctive license tags issued under this section. The State
- 49 Treasurer shall distribute such collections as follows:
- 50 (a) Twenty-four Dollars (\$24.00) of each additional fee
- 51 collected on distinctive license tags issued under this section
- 52 shall be <u>distributed to the Mississippi Constables Association</u>.
- (b) One Dollar (\$1.00) of each additional fee collected
- 54 on distinctive license tags issued under this section shall be
- 55 deposited into the Mississippi Fire Fighter's Memorial Burn Center
- 56 Fund created under Section 7-9-70.
- 57 (c) Two Dollars (\$2.00) of each additional fee
- 58 collected on distinctive license tags issued under this section
- 59 shall be deposited to the credit of the State Highway Fund to be

- 60 expended solely for the repair, maintenance, construction or
- 61 reconstruction of highways.
- 62 (d) One Dollar (\$1.00) of each additional fee collected
- on distinctive license tags issued pursuant to this section shall
- 64 be deposited to the credit of the special fund created in Section
- 65 27-19-44.2.
- 66 (5) A regular license tag must be properly displayed as
- 67 required by law until replaced by a distinctive license tag issued
- 68 under this section. The regular license tag must be surrendered
- 69 to the tax collector upon issuance of the distinctive license tag
- 70 under this section. The tax collector shall issue up to two (2)
- 71 license decals for each distinctive license tag issued under this
- 72 section, which will expire the same month and year as the regular
- 73 license tag.
- 74 (6) In the case of loss or theft of a distinctive license
- 75 tag issued under this section, the owner may make application and
- 76 affidavit for a replacement distinctive license tag as provided by
- 77 Section 27-19-37. The fee for a replacement distinctive license
- 78 tag shall be Ten Dollars (\$10.00). The tax collector receiving
- 79 such application and affidavit shall be entitled to retain and
- 80 deposit in the county general fund five percent (5%) of the fee
- 81 for such replacement license tag and the remainder shall be
- 82 distributed in the same manner as funds from the sale of regular
- 83 distinctive license tags issued under this section.
- 84 **SECTION 2.** This act shall take effect and be in force from
- 85 and after July 1, 2005.
