7	SECTION 1. Section 27-7-91, Mississippi Code of 1972, is
8	amended as follows:
9	27-7-91. (1) Each resident individual taxpayer who files a
10	Mississippi income tax return and who will receive a tax refund
11	from the State Tax Commission may designate that a contribution be
12	made to the "Mississippi Wildlife, Fisheries and Parks Foundation"
13	by marking the appropriate box printed on the return pursuant to
14	this subsection. In the case of a joint return, each spouse may
15	designate that a portion of the refund shall be paid to the
16	foundation.
17	The State Tax Commission shall print on the Mississippi
18	income tax form for residents a space for designating the
19	contribution in substantially the following form:
20	"MISSISSIPPI WILDLIFE, FISHERIES AND PARKS FOUNDATION.
21	I wish to contribute ()\$1 ()\$5 ()\$10 () other \$ of my
22	TAX REFUND TO THE MISSISSIPPI WILDLIFE, FISHERIES AND PARKS

instructions accompanying the individual income tax form the

purposes for which the contributions authorized herein shall be

used.

- 28 (3) This section shall apply to taxable years beginning on 29 or after January 1, 2005.
- SECTION 2. Section 27-7-93, Mississippi Code of 1972, is 30
- 31 amended as follows:
- 32 27-7-93. (1) The Chairman of the State Tax Commission shall
- determine annually the total amount designated by individuals to 33
- be paid to the foundation, along with all interest earned thereon, 34
- and shall report such amount to the State Treasurer who shall pay 35
- such amount into the Mississippi Wildlife, Fisheries and Parks 36
