5	SECTION 1. The following sum of money, or so much thereof as			
6	may be necessary, is hereby appropriated out of any money in the			
7	State Treasury to the credit of the Mississippi Motor Vehicle			
8	Commission, as provided by Section 63-17-51 et seq., Mississippi			
9	Code of 1972, for the purpose of defraying the expenses of said			
10	Commission, for the fiscal year beginning July 1, 2005, and ending			
11	June 30, 2006\$ 233,864.00.			
12	SECTION 2. Of the funds appropriated under the provisions of			
13	Section 1, not more than the amounts set forth below shall be

- 67 **SECTION 3.** It is the intention of the Legislature that none
- 68 of the funds appropriated under the provisions of this act shall
- 69 be expended to defray any expenses of the Motor Vehicle Commission
- 70 if said commission takes any official actions during Fiscal Year
- 71 2006 that serve directly or indirectly to reduce the payment to
- 72 the State General Fund of any sales tax on motor vehicles sold
- 73 within the State of Mississippi.
- 74 It is further the intention of the Legislature that if such
- 75 actions are taken by the Motor Vehicle Commission during Fiscal
- 76 Year 2006, the executive director and commission members shall be
- 77 held personally liable for repayment of any funds expended under
- 78 the provisions of this act with said repayment to be made to the
- 79 State General Fund. The Attorney General is hereby authorized and
- 80 directed to undertake appropriate legal action to enforce the
- 81 provisions of this act and to recover said funds.
- 82 **SECTION 4.** The money herein appropriated shall be paid by
- 83 the State Treasurer out of any money in the State Treasury to the
- 84 credit of the proper fund or funds as set forth in this act, upon
- 85 warrants issued by the State Fiscal Officer; and the State Fiscal
- 86 Officer shall issue his warrants upon requisitions signed by the
- 87 proper person, officer or officers in the manner provided by law.
- 88 **SECTION 5.** This act shall take effect and be in force from
- 89 and after July 1, 2005.
