SENATE BILL NO. 3096

1 AN ACT MAKING AN APPROPRIATION OF SPECIAL FUNDS TO DEFRAY THE
2 EXPENSES OF THE MISSISSIPPI STATE BOARD OF VETERINARY EXAMINERS
3 FOR FISCAL YEAR 2006.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

5 SECTION 1. That the following sum, or so much thereof as may
6 be necessary, is hereby appropriated out of any money in the State
7 Treasury to the credit of the Mississippi State Board of
8 Veterinary Examiners for the purpose of defraying the expenses
9 incurred by said board for the fiscal year beginning July 1, 2005,
10 and ending June 30, 2006..... \$ 96,205.00.

11 SECTION 2. Of the funds appropriated under the provisions of
12 Section 1, not more than the amounts set forth below shall be
13 expended for the respective major objects or purposes of
14 expenditure:

15 MAJOR OBJECTS OF EXPENDITURE:

16 Personal Services:

17 Salaries, Wages and Fringe Benefits.. \$ 3,600.00
18 Travel and Subsistence..... 12,000.00
19 Contractual Services..... 79,815.00
20 Commodities..... 790.00

21 Capital Outlay:

22 Other Than Equipment..... 0.00
23 Equipment..... 0.00
24 Subsidies, Loans and Grants..... 0.00
25 Total..... \$ 96,205.00

26 **SECTION 3.** Any transfers or escalations shall be made in
27 accordance with the terms, conditions, and procedures established
28 by law.

29 No general funds authorized to be expended herein shall be
30 used to replace federal funds and/or other special funds which are
31 being used for salaries authorized under the provisions of this
32 act and which are withdrawn and no longer available.

33 **SECTION 4.** It is the intention of the Legislature that the
34 Mississippi State Board of Veterinary Examiners is hereby
35 authorized to accept, budget, and expend funds, not to exceed
36 Fifty Thousand Dollars (\$50,000.00) from any source in accordance
37 with the rules and regulations of the Department of Finance and
38 Administration in a manner consistent with the escalation of
39 federal funds.

40 **SECTION 5.** The money herein appropriated shall be paid by
41 the State Treasurer out of any money in the State Treasury to the
42 credit of the proper fund or funds as set forth in this act, upon
43 warrants issued by the State Fiscal Officer; and the State Fiscal
44 Officer shall issue his warrants upon requisitions signed by the
45 proper person, officer or officers in the manner provided by law.

46 **SECTION 6.** This act shall take effect and be in force from
47 and after July 1, 2005.
