5	SECTION 1. That the following sum, or so much thereof as may	
6	be necessary, is hereby appropriated out of any money in the State	
7	Treasury to the credit of the Mississippi State Board of	
8	Veterinary Examiners for the purpose of defraying the expenses	
9	incurred by said board for the fiscal year beginning July 1, 2005,

- SECTION 3. Any transfers or escalations shall be made in accordance with the terms, conditions, and procedures established by law.
- No general funds authorized to be expended herein shall be
- 30 used to replace federal funds and/or other special funds which are
- 31 being used for salaries authorized under the provisions of this
- 32 act and which are withdrawn and no longer available.
- 33 **SECTION 4.** It is the intention of the Legislature that the
- 34 Mississippi State Board of Veterinary Examiners is hereby
- 35 authorized to accept, budget, and expend funds, not to exceed
- 36 Fifty Thousand Dollars (\$50,000.00) from any source in accordance
- 37 with the rules and regulations of the Department of Finance and
- 38 Administration in a manner consistent with the escalation of
- 39 federal funds.
- 40 **SECTION 5.** The money herein appropriated shall be paid by
- 41 the State Treasurer out of any money in the State Treasury to the
