SENATE BILL NO. 3111

1 AN ACT MAKING AN ADDITIONAL APPROPRIATION OF SPECIAL FUNDS 2 FOR THE PURPOSE OF DEFRAYING THE EXPENSES OF THE MISSISSIPPI STATE 3 BOARD OF CONTRACTORS, MISSISSIPPI STATE OIL AND GAS BOARD, 4 MISSISSIPPI STATE BOARD OF DENTAL EXAMINERS, THE MISSISSIPPI 5 PUBLIC SERVICE COMMISSION, AND THE MISSISSIPPI COMMISSION ON 6 JUDICIAL PERFORMANCE FOR FISCAL YEAR 2005.

7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: **SECTION 1.** In addition to all other sums heretofore 8 9 appropriated, the following sum, or so much thereof as may be 10 necessary, is hereby appropriated out of any money in the State Treasury to the credit of the Mississippi State Board of 11 Contractors, for the purpose of allocating funds to the 12 Mississippi Housing Institute for education and professional 13 development as authorized in House Bill No. 796, 2004 Regular 14 Session, for said Board, for the fiscal year ending June 30, 15 2005....\$ 100,000.00. 16

SECTION 2. In addition to all other sums heretofore appropriated, the following sum, or so much thereof as may be necessary, is hereby appropriated out of any money in the State Treasury to the credit of the Mississippi State Oil and Gas Board, for the purpose of developing computer software for reports and permitting forms to be submitted via the internet for said Board, for the fiscal year ending June 30, 2005......\$ 125,000.00.

SECTION 3. In addition to all other sums heretofore 24 appropriated, the following sum, or so much thereof as may be 25 necessary, is hereby appropriated out of any money in the State 26 27 Treasury to the credit of the Mississippi State Board of Dental Examiners, for the purpose of hiring a Licensing Investigator IV 28 position and providing funding for increased travel expenses due 29 *SS05/ANAP8* S. 30 to the development of a national clinical licensure examination by 31 the Board, for the fiscal year ending June 30, 2005..... 32 7,000.00. 33 SECTION 4. In addition to all other sums heretofore 34 appropriated, the following sum, or so much thereof as may be 35 necessary, is hereby appropriated out of any money in the State 36 Treasury to the credit of the Mississippi Public Service Commission, for the purpose of funding salary increases for two 37 court reporters as authorized in Senate Bill No. 2647, 2004 38 39 Regular Session, unused leave payments for three positions, 40 Workers' Compensation and Unemployment Insurance premium payments for said Commission, for the fiscal year ending June 30, 2005..... 41\$ 100,000.00. 42 In addition to all other sums heretofore 43 SECTION 5. appropriated, the following sum, or so much thereof as may be 44 necessary, is hereby appropriated out of any money in the State 45 46 Treasury to the credit of the Mississippi Commission on Judicial 47 Performance, for the purpose of providing supplemental funding to the Commission pursuant to Senate Bill No. 2892, 2004 Regular 48 49 Session, for all major object expenditure categories, excluding "Salaries, Wages and Fringe Benefits", for the fiscal year ending 50 51 June 30, 2005.....\$ 55,000.00. SECTION 6. The money herein appropriated shall be paid by 52 53 the State Treasurer out of any money in the proper fund or funds 54 as set forth in this act, upon warrants issued by the State Fiscal Officer; and the State Fiscal Officer shall issue his warrants 55 56 upon requisitions signed by the proper person, officer or officers 57 in the manner provided by law.

58 **SECTION 7.** This act shall take effect and be in force from 59 and after its passage.
