SENATE CONCURRENT RESOLUTION NO. 551

1 A CONCURRENT RESOLUTION COMMENDING THE PUBLIC AND CIVIC
2 SERVICE OF JOHN V. CORRERO, LONGTIME EXECUTIVE DIRECTOR OF THE
3 MISSISSIPPI STATE UNIVERSITY ALUMNI ASSOCIATION, AND
4 CONGRATULATING HIM ON THE OCCASION OF HIS RETIREMENT.

5 WHEREAS, John V. Correrero, Executive Director of the
6 Mississippi State University Alumni Association since 1994, has
7 announced his retirement effective June 30, 2005; and

8 WHEREAS, John's legacy and dedication to Mississippi State

22 University, he received his B.S. Degree in Physical Education and
23 Social Studies Education from Mississippi State University in
24 1962, and his Masters in Educational Administration and Counseling
25 from MSU in 1964, served as Graduate Assistant at MSU from
26 1962-1963, served as Assistant Freshman Football Coach at MSU from
27 1963-1964, was Teacher and Assistant Football Coach at
28 Natchez-Adams County High School from 1964-1967, and Athletic

29 Director and Head Football Coach at Natchez-Adams County High
30 School from 1967-1969; and
