## SENATE CONCURRENT RESOLUTION NO. 569

1 A CONCURRENT RESOLUTION SUSPENDING THE DEADLINES FOR THE  
2 PURPOSE OF THE FURTHER CONSIDERATION AND PASSAGE OF SENATE BILL  
3 NO. 3039, 2005 REGULAR SESSION, ENTITLED "AN ACT MAKING AN  
4 ADDITIONAL APPROPRIATION OF GENERAL AND SPECIAL FUNDS TO DEFRAY  
5 THE EXPENSES OF THE GOVERNOR'S OFFICE - DIVISION OF MEDICAID, THE  
6 DEPARTMENT OF HUMAN SERVICES, THE MISSISSIPPI DEPARTMENT OF  
7 CORRECTIONS, STATE OF MISSISSIPPI BONDS AND INTEREST, DEPARTMENT  
8 OF REHABILITATION SERVICES, OFFICE OF THE ATTORNEY GENERAL, THE  
9 STATE TAX COMMISSION, THE DEPARTMENT OF MENTAL HEALTH, ALCORN  
10 STATE UNIVERSITY, AND MISSISSIPPI VALLEY STATE UNIVERSITY FOR  
11 FISCAL YEARS 2005 AND 2006."

13 HOUSE OF REPRESENTATIVES CONCURRING THEREIN, That the following  
14 bill is hereby exempt from the timetable for consideration of

16 given for further consideration of Senate Bill No. 3039, 2005
