- 22 individuals and general officers; and
- 23 WHEREAS, Company G was called on to transport the top 10 most
- 24 wanted Iraqi prisoners; and
- 25 WHEREAS, Company G provided valuable aircraft flight training
- 26 to pilots from other states; and

28	their deployment in Iraq with no casualties or serious incidents;
