## MR. SPEAKER AND MADAM PRESIDENT:

We, the undersigned conferees, have had under consideration the amendments to the following entitled BILL:

H. B. No. 887: Deer hunting; establish separate seasons for southeastern part of state.

We, therefore, respectfully submit the following report and recommendation:

- That the Senate recede from its Amendment No. 1.
- 2. That the House and Senate adopt the following amendment:

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

- 10 SECTION 1. (1) When hunting deer during any gun season on
- deer, a hunter must wear in full view at least five hundred (500) 11
- 12 square inches of solid unbroken fluorescent orange.
- 13 requirement shall not apply to a hunter while the hunter is in a
- 14 fully enclosed deer stand.
- (2) A violation of this section is a Class III violation and 15
- is punishable as provided in Section 49-7-143. 16
- SECTION 2. The open season for game birds shall be as 17
- follows: 18
- On bobwhite quail: The season shall open on 19 (a)
- 20 Thanksgiving Day and run through the first Saturday in March next
- 21 following.
- 22 (b) On pheasant: There shall be no open season on
- 23 pheasant.
- (c) On wild turkey: The commission may fix the spring 2.4
- 25 season between March 1 and May 15. In addition, the commission
- may fix special fall either-sex seasons. 26
- 27 On migratory birds: The open season for migratory
- 28 birds shall be the season prescribed by the Federal Migratory Bird
- 29 Treaty regulations.

- 30 **SECTION 3.** The open season on game animals except deer shall
- 31 be as follows:
- 32 (a) On squirrel:
- 33 (i) Zone 1: For areas north of Highway 82 plus
- 34 those portions of Sunflower County and Washington County south of
- 35 Highway 82 the season shall open on the Saturday nearest October 1
- 36 and run through February 28.
- 37 (ii) Zone 2: For areas between Highway 82 and
- 38 Highway 84, plus such portions of the state south of Highway 84
- 39 and west of Interstate 55, the season shall open on the Saturday
- 40 nearest October 15 and run through February 28.
- 41 (iii) Zone 3: For areas south of Highway 84 and
- 42 east of Interstate 55 the season shall open on the last Saturday
- 43 in October and run through February 28.
- (b) On rabbits: The season shall open on the Saturday
- 45 nearest October 15 and run through February 28 next following, and
- 46 when rabbits are depredating or destroying crops, the owner of the
- 47 crops or his tenants may shoot the rabbits with guns.
- 48 **SECTION 4.** Section 49-7-31, Mississippi Code of 1972, is
- 49 amended as follows:
- 50 49-7-31. (1) The open season \* \* \* on deer shall be as
- 51 follows:
- 52 **\* \* \***
- 53 (a) With bow and arrow: October 1 through the Friday
- 54 prior to Thanksgiving.
- (b) With guns and with dogs: From the Saturday prior
- 56 to Thanksgiving through December 1.
- 57 <u>(c)</u> With primitive weapons and without dogs: December
- 58 2 through December 15.
- (d) With guns and without dogs: December 16 through
- 60 December 23. However, the commission may allow hunting statewide
- or in specific areas with any legal weapon which it may designate

- without dogs after the end of the last season for hunting deer 62 63 with guns and with dogs, but the season with legal designated weapons and without dogs shall not extend beyond January 31. 64 65 (e) The commission shall establish an extended season with primitive weapons and bow and arrow without dogs from 66 67 February 1 through February 15 for the area south of U.S. Highway 84 and east of Mississippi Highway 35 only for legal bucks. Any 68 antlered deer taken in this area during any open season under this 69 70 section must be a legal buck as defined in this paragraph. For purposes of this paragraph, the term "legal buck" means a deer 71 72 with antlers of four (4) points or more with a minimum inside spread of ten (10) inches or a minimum main beam length of 73 thirteen (13) inches. The commission may delay the opening date 74 75 and change the length of bow and arrow season in paragraph (1)(a) in this area. 76
- 77 (f) With guns and with dogs: December 24 through a date fixed by the commission that will provide a total of 78 79 thirty-nine (39) days of hunting deer with guns and with dogs when added to the number of days provided for hunting deer with guns 80 81 and with dogs in paragraph (b).
- 82
- (2) \* \* \* The commission may \* \* \* set and regulate the deer 83 seasons on wildlife management areas which it administers. 84
- 85 (3) (a) The commission may allow the harvesting of 86 antlerless deer in the districts or zones upon the recommendation 87 of the executive director based upon good and substantial quantitative data and research evaluations that demonstrate that 88 the harvesting is necessary to properly manage the herd. 89
- 90 (b) The commission, only upon the recommendation of the 91 executive director, may allow the harvesting of antlerless deer 92 during the deer season with guns and with dogs by a majority vote 93 of the commission.

- 94 <u>(c)</u> Nothing in this subsection prohibits the harvesting 95 of either-sex deer by landowners or leaseholders on private lands 96 under a deer management program prescribed or approved by the
- 98 (4) The commission may provide a special permit for the
  99 harvesting of deer when they are depredating and destroying crops.
  100 The department shall supervise the harvesting and provide for the
  101 salvaging of the meat of the animals. The commission may
  102 authorize the department to assist any farmer in this state, who
  103 sustains crop damage by wildlife, in eradication of the problem

- 106 SECTION 5. (1) The commission shall establish a special 107 hunting season for youth under the age of sixteen (16) and for handicapped persons in the Natchez State Park. The commission 108 109 shall also establish a primitive weapon season in the Natchez 110 State Park. The selection of participants in the primitive weapon 111 season shall be by public drawing from all qualified applications. The commission shall set the number of permits to be issued and 112 113 the length of the special seasons.
  - (2) The commission may also establish a special hunting season for youth and handicapped persons or a primitive weapon season as provided in this section in any other state park under the jurisdiction of the department but shall only do so upon the recommendation of the staff of the department as approved by the commission. The commission shall select participants and set the number of permits to be issued and the length of the special seasons.
- 122 (3) The commission may establish and regulate special youth 123 hunts for all nonmigratory game birds and animals outside of the 124 open season on wildlife management areas and on private lands.

- 125 **SECTION 6.** (1) The commission may fix the open season on
- 126 fur-bearing animals between November 1 and March 1 next following
- 127 and fix the open season for hunting opossums, raccoons and bobcats
- 128 with dogs and guns by licensed hunters from October 1 to February
- 129 28 next following; but raccoons and bobcats may be run, hunted,
- 130 chased or pursued throughout the year with dogs by licensed
- 131 hunters.
- 132 (2) The commission may establish an additional open season
- 133 on raccoon from July 1 through October 1, and the bag limit on
- 134 raccoon during the additional open season shall be one (1) per
- 135 party, per night.
- 136 **SECTION 7.** (1) (a) The hunting of predatory animals shall
- 137 be restricted to the open seasons for hunting any game animal or
- 138 game bird, using only the firearms, ammunition, primitive weapons
- 139 or archery equipment legal for use during that open season.
- 140 (b) Landowners, agricultural leaseholders or their
- 141 designated agents may take predatory animals year-round on lands
- 142 owned or leased by them.
- 143 (2) The taking of any animal or animals other than beavers,
- 144 nutria or coyote by the use of a trap or traps is unlawful except
- 145 during the time the season is open for the taking of fur-bearing
- 146 animals.
- 147 (3) Fox and coyote may be run, chased or pursued with dogs
- 148 except as provided in Section 49-7-32 year-round by licensed
- 149 hunters.
- 150 (4) It is unlawful to trap fox after the closed season for
- 151 trapping of other fur-bearing animals, except on property owned or
- 152 leased by the person trapping.
- 153 SECTION 8. This act shall take effect and be in force from
- 154 and after July 1, 2005.

Further, amend by striking the title in its entirety and inserting in lieu thereof the following:

AN ACT TO REVISE THE REQUIREMENTS FOR WEARING HUNTER ORANGE; TO PROVIDE A PENALTY FOR NOT WEARING HUNTER ORANGE; TO RECODIFY OPEN SEASON LAWS ON GAME ANIMALS AND BIRDS, FUR-BEARING ANIMALS AND PREDATORS; TO AMEND SECTION 49-7-31, MISSISSIPPI CODE OF 1972, TO CONFORM; TO FURTHER AMEND 49-7-31, MISSISSIPPI CODE OF 1972, TO PROVIDE FOR AN EXTENDED DEER SEASON ON BUCKS WITH CERTAIN MINIMUM ANTLER SIZES IN CERTAIN COUNTIES IN SOUTH MISSISSIPPI; AND FOR RELATED PURPOSES.
