We, the undersigned conferees, have had under consideration the amendments to the following entitled BILL:

We, therefore, respectfully submit the following report and recommendation:

- 2. That the House and Senate adopt the following amendment:

- The agency shall not take any action to promote or otherwise award salary increases through reallocation, reclassification, realignment, education benchmark, career ladder, or any other means to increase salaries of employees or positions, except for the award of teacher pay increases.
- 78 SECTION 3. It is the intention of the Legislature that the 79 Board of Trustees of the Public Employees' Retirement System shall maintain complete accounting and personnel records related to the 80 81 expenditure of all funds appropriated under this act and that such 82 records shall be in the same format and level of detail as 83 maintained for Fiscal Year 2005. It is further the intention of 84 the Legislature that the agency's budget request for Fiscal Year 85 2007 shall be submitted to the Joint Legislative Budget Committee in a format and level of detail comparable to the format and level 86 of detail provided during the Fiscal Year 2006 budget request 87 88 process.
