REPORT OF CONFERENCE COMMITTEE

We, the undersigned conferees, have had under consideration the amendments to the following entitled BILL:

H. B. No. 1644: Appropriation; Office of Capital Defense Counsel.We, therefore, respectfully submit the following report and recommendation:

1. That the Senate recede from its Amendment No. 1.

2. That the House and Senate adopt the following amendment:

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

5	SECTION 1. The following sum, or so much thereof as may be

16	July 1, 2005, and ending June 30, 2006\$ 790,570.00.				
17	SECTION 3. Of the funds appropriated under the provisions of				
18	Section 1, not more than the amounts set forth below shall be				
19	expended for the respective major objects or purposes of

37 Any transfers or escalations shall be made in accordance with 38 the terms, conditions, and procedures established by law.

No general funds authorized to be expended herein shall be used to replace federal funds and/or other special funds which are being used for salaries authorized under the provisions of this act and which are withdrawn and no longer available.

SECTION 4. It is the intention of the Legislature that the 43 44 Office of Capital Defense Counsel shall maintain complete accounting and personnel records related to the expenditure of all 45 46 funds appropriated under this act and that such records shall be in the same format and level of detail as maintained for Fiscal 47 Year 2005. It is further the intention of the Legislature that 48 49 the agency's budget request for Fiscal Year 2007 shall be 50 submitted to the Joint Legislative Budget Committee in a format 51 and level of detail comparable to the format and level of detail provided during the Fiscal Year 2006 budget request process. 52

53 SECTION 5. It is the intention of the Legislature that the 54 Director of the Office of Capital Defense Counsel shall have the 55 authority to accept, budget and expend any source funds, not to 56 exceed Two Hundred Thousand Dollars (\$200,000.00). Such funds are 57 to be escalated in accordance with the rules and regulations of

the Department of Finance and Administration in a manner 58 59 consistent with escalation of federal funds.

60 SECTION 6. The money herein appropriated shall be paid by the State Treasurer out of any money in the State Treasury to the 61 credit of the proper fund or funds as set forth in this act, upon 62 warrants issued by the State Fiscal Officer; and the State Fiscal 63 64 Officer shall issue his warrants upon requisitions signed by the proper person, officer or officers, in the manner provided by law. 65 SECTION 7. This act shall take effect and be in force from 66 67 and after July 1, 2005.
