House Amendments to Senate Bill No. 2730

TO THE SECRETARY OF THE SENATE:

THIS IS TO INFORM YOU THAT THE HOUSE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:

AMENDMENT NO. 1

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

8 SECTION 1. Section 31-9-13, Mississippi Code of 1972, is
9 amended as follows:

31-9-13. In lieu of regular appropriations, the Office of 10 11 General Services may assess against each institution, agency or individual acquiring surplus property from and through the Office 12 of General Services a fee or commission on each item in sufficient 13 14 amount to establish and maintain a revolving fund, to be used to operate and support the Office of General Services. 15 The Office of 16 General Services shall follow the procedure outlined by the United 17 States Department of Health and Human Services in establishing the fund, and the fund shall never exceed more than One Million 18 19 Dollars (\$1,000,000.00) above and beyond four (4) months of operating expenses of the Office of General Services. 20

21 With this revolving fund so acquired, the Office of General 22 Services shall meet all items of expense incurred in acquiring, transporting, warehousing and distributing property to eligible 23 applicants and also all items of expense incident to the operation 24 of the offices of the Office of General Services, including 25 salaries, office supplies and necessary general expenses, and all 26 27 other items as are covered by legislative appropriation for those 28 purposes.

29 <u>The Office of General Services may escalate, budget and</u>
30 <u>expend funds from the revolving fund in an amount not to exceed</u>
31 <u>Two Hundred Fifty Thousand Dollars (\$250,000.00) in any one (1)</u>
32 <u>fiscal year to carry out the provisions of this section.</u>
33 This section shall stand repealed July 1, 2006.

AN ACT TO AMEND SECTION 31-9-13, MISSISSIPPI CODE OF 1972, TO INCREASE THE MAXIMUM AMOUNT THAT MAY BE IN THE REVOLVING FUND USED TO OPERATE AND SUPPORT THE OFFICE OF GENERAL SERVICES; TO AUTHORIZE THE OFFICE OF GENERAL SERVICES TO ESCALATE, BUDGET AND EXPEND UP TO \$250,000.00 FROM THE REVOLVING FUND IN A FISCAL YEAR; AND FOR RELATED PURPOSES.
