SECTION 4. The money herein appropriated shall be paid by 48 49 the State Treasurer out of any money in the State Treasury to the credit of the proper fund or funds as set forth in this act, upon 50 warrants issued by the State Fiscal Officer; and the State Fiscal 51 Officer shall issue his warrants upon requisitions signed by the 52 53 proper person, officer or officers, in the manner provided by law. 54 SECTION 5. This act shall take effect and be in force from and after July 1, 2005. 55
