

**House Amendments to Senate Bill No. 3048**

**TO THE SECRETARY OF THE SENATE:**

**THIS IS TO INFORM YOU THAT THE HOUSE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:**

**AMENDMENT NO. 1**

**Amend by striking all after the enacting clause and inserting in lieu thereof the following:**

6           **SECTION 1.** The following sum, or so much thereof as may be  
7 necessary, is hereby appropriated out of any money in the State  
8 General Fund not otherwise appropriated, for expenses of the  
9 Executive Department, being the Governor's office and staff, for  
10 the fiscal year beginning July 1, 2005, and ending June 30, 2006,  
11 ..... \$           1,737,654.00.

12           **SECTION 2.** The following sum, or so much thereof as may be  
13 necessary, is hereby appropriated out of any money in the State  
14 Treasury to the credit of the Governor's Office for the purpose of  
15 defraying the expenses incurred by the Executive Department, being  
16 the Governor's office and staff, for the fiscal year beginning  
17 July 1, 2005, and ending June 30, 2006.....\$           589,717.00.

18           **SECTION 3.** Of the funds appropriated under the provisions of  
19 Sections 1 and 2, not more than the amounts set forth below shall  
20 be expended for the respective major objects or purposes of  
21 expenditure:

50 General Fund not otherwise appropriated, for expenses incidental  
51 to the proper operation of the Governor's Mansion and residence of  
52 the Governor for the fiscal year beginning July 1, 2005, and  
53 ending June 30, 2006..... \$ 387,076.00.

54 **SECTION 5.** Of the funds appropriated under the provisions of  
55 Section 4, not more than the amounts set forth below shall be  
56 expended for the respective major objects or purposes of  
57 expenditure:

80 **SECTION 6.** The money herein appropriated shall be paid by  
81 the State Treasurer out of any money in the State Treasury to the  
82 credit of the proper fund or funds as set forth in this act, upon  
83 warrants issued by the State Fiscal Officer; and the State Fiscal  
84 Officer shall issue his warrants upon requisitions signed by the  
85 proper person, officer or officers, in the manner provided by law.

86 **SECTION 7.** This act shall take effect and be in force from  
87 and after July 1, 2005.
