## House Amendments to Senate Bill No. 3111

## AMENDMENT NO. 1

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

21	Treasury to the credit of the Mississippi State Oil and Gas Board,
22	for the purpose of developing computer software for reports and
23	permitting forms to be submitted via the Internet for said Board,
24	for the fiscal year ending June 30, 2005 108,000.00.
25	SECTION 3. In addition to all other sums heretofore
26	appropriated, the following sum, or so much thereof as may be
27	necessary, is hereby appropriated out of any money in the State
28	Treasury to the credit of the Mississippi State Board of Dental
29	Examiners, for the purpose of hiring a Licensing Investigator IV
30	position and providing funding for increased travel expenses due
31	to the development of a national clinical licensure examination by
32	the Board, for the fiscal year ending June 30, 2005
33	\$ 7,000.00.

34 SECTION 4. In addition to all other sums heretofore 35 appropriated, the following sum, or so much thereof as may be necessary, is hereby appropriated out of any money in the State 36 37 Treasury to the credit of the Mississippi Public Service Commission, for the purpose of funding salary increases for two 38 39 court reporters as authorized in Senate Bill No. 2647, 2004 Regular Session, unused leave payments for three positions, 40 41 Workers' Compensation and Unemployment Insurance premium payments 42 for said Commission, for the fiscal year ending June 30, 2005..... 43 100,000.00. 44 SECTION 5. In addition to all other sums heretofore appropriated, the following sum, or so much thereof as may be 45 46 necessary, is hereby appropriated out of any money in the State Treasury to the credit of the Mississippi Commission on Judicial 47 48 Performance, for the purpose of providing supplemental funding to 49 the Commission pursuant to Senate Bill No. 2892, 2004 Regular Session, for all major object expenditure categories, excluding 50 51 "Salaries, Wages and Fringe Benefits", for the fiscal year ending 52 June 30, 2005.....\$ 55,000.00. SECTION 6. In addition to all other sums heretofore 53 54 appropriated, the following sum, or so much thereof as may be 55 necessary, is hereby appropriated out of any money in the Health Care Expendable Fund created in Section 43-13-407, Mississippi 56 57 Code of 1972, to defray the expenses of the Mississippi State 58 Department of Health for the purpose of providing funds to the Qualified Health Centers, for the fiscal year ending June 30, 2005 59 60 .....\$ 160,000.00. SECTION 7. The money herein appropriated shall be paid by 61 62 the State Treasurer out of any money in the proper fund or funds 63 as set forth in this act, upon warrants issued by the State Fiscal Officer; and the State Fiscal Officer shall issue his warrants 64 65 upon requisitions signed by the proper person, officer or officers 66 in the manner provided by law.

SECTION 8. This act shall take effect and be in force from

and after its passage.
