## Amend by striking all after the enacting clause and inserting in lieu thereof the following:

SECTION 1. The following sum, or so much thereof as may be			
necessary, is hereby appropriated out of any money in the State			
Treasury to the credit of the Mississippi Institute for Forest			
Inventory which is comprised of special source funds and donations			
collected by or otherwise available to the Institute for the			
purpose of defraying the expenses of the Institute for the period			
beginning July 1, 2005, and ending June 30, 2006

32 With the funds herein appropriated, it is the intention of 33 the Legislature that it shall be the agency's responsibility to 34 make certain that funds required to be appropriated for "Personal Services" for Fiscal Year 2007 do not exceed Fiscal Year 2006 35 36 funds appropriated for that purpose, unless programs or positions 37 are added to the agency's Fiscal Year 2007 budget by the Mississippi Legislature. Based on data provided by the 38 Legislative Budget Office, the State Personnel Board shall 39 40 determine and publish the projected annual cost to fully fund all 41 appropriated positions in compliance with the provisions of this It shall be the responsibility of the agency head to insure 42 act. 43 that no single personnel action increases this projected annual cost and/or the Fiscal Year 2006 appropriation for "Personal 44 45 Services" when annualized, with the exception of escalated funds. If, at the time the agency takes any action to change "Personal 46 Services," the State Personnel Board determines that the agency 47 48 has taken an action which would cause the agency to exceed this projected annual cost or the Fiscal Year 2006 "Personal Services" 49 50 appropriated level, when annualized, then only those actions which reduce the projected annual cost and/or the appropriation 51 52 requirement will be processed by the State Personnel Board until such time as the requirements of this provision are met. 53 54 Any transfers or escalations shall be made in accordance with

55 the terms, conditions and procedures established by law or

allowable under the terms set forth within this act. The State Personnel Board shall not escalate positions without written approval from the Department of Finance and Administration. The Department of Finance and Administration shall not provide written approval to escalate any funds for salaries and/or positions without proof of availability of new or additional funds above the appropriated level.

No general funds authorized to be expended herein shall be used to replace federal funds and/or other special funds which are being used for salaries authorized under the provisions of this act and which are withdrawn and no longer available.

67 SECTION 3. This appropriation is made for the purpose of 68 providing funds to defray the expenses of the Mississippi 69 Institute for Forest Inventory as established in Section 70 49-19-403, Mississippi Code of 1972.

SECTION 4. It is the intention of the Legislature that the Mississippi Institute for Forest Inventory is hereby authorized to accept, budget and expend funds, not to exceed One Million Dollars (\$1,000,000.00), from any source in accordance with rules and regulations of the Department of Finance and Administration in a manner consistent with the escalation of federal funds.

77 SECTION 5. The money herein appropriated shall be paid by 78 the State Treasurer out of any money in the proper fund or funds 79 as set forth in this act, upon warrants issued by the State Fiscal 80 Officer; and the State Fiscal Officer shall issue his warrants 81 upon requisitions signed by the proper person, officer or officers 82 in the manner provided by law.

83 **SECTION 6.** This act shall take effect and be in force from 84 and after July 1, 2005.
