Senate Amendments to House Bill No. 1619

THIS IS TO INFORM YOU THAT THE SENATE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:

AMENDMENT NO. 1

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

6	SECTION 1. The following sum, or so much of it as may be

With the funds herein appropriated, it is the intention of 33 the Legislature that it shall be the agency's responsibility to 34 35 make certain that funds required to be appropriated for "Personal Services" for Fiscal Year 2007 do not exceed Fiscal Year 2006 36 37 funds appropriated for that purpose, unless programs or positions are added to the agency's Fiscal Year 2007 budget by the 38 39 Mississippi Legislature. Based on data provided by the 40 Legislative Budget Office, the State Personnel Board shall determine and publish the projected annual cost to fully fund all 41 42 appropriated positions in compliance with the provisions of this It shall be the responsibility of the agency head to insure 43 act. that no single personnel action increases this projected annual 44 cost and/or the Fiscal Year 2006 appropriation for "Personal 45 46 Services" when annualized, with the exception of escalated funds. 47 If, at the time the agency takes any action to change "Personal Services," the State Personnel Board determines that the agency 48 49 has taken an action which would cause the agency to exceed this 50 projected annual cost or the Fiscal Year 2006 "Personal Services" 51 appropriated level, when annualized, then only those actions which 52 reduce the projected annual cost and/or the appropriation 53 requirement will be processed by the State Personnel Board until 54 such time as the requirements of this provision are met.

55 Any transfers or escalations shall be made in accordance with the terms, conditions and procedures established by law or 56 57 allowable under the terms set forth within this act. The State Personnel Board shall not escalate positions without written 58 approval from the Department of Finance and Administration. The 59 60 Department of Finance and Administration shall not provide written approval to escalate any funds for salaries and/or positions 61 without proof of availability of new or additional funds above the 62 appropriated level. 63

64 No general funds authorized to be expended herein shall be 65 used to replace federal funds and/or other special funds which are

being used for salaries authorized under the provisions of thisact and which are withdrawn and no longer available.

SECTION 3. It is the intention of the Legislature that the 68 69 Board of Examiners for Social Workers and Marriage and Family Therapists shall maintain complete accounting and personnel 70 71 records related to the expenditure of all funds appropriated under 72 this act and that such records shall be in the same format and level of detail as maintained for Fiscal Year 2005. It is further 73 74 the intention of the Legislature that the agency's budget request for Fiscal Year 2007 shall be submitted to the Joint Legislative 75 76 Budget Committee in a format and level of detail comparable to the format and level of detail provided during the Fiscal Year 2006 77 78 budget request process.

79 SECTION 4. The money herein appropriated shall be paid by 80 the State Treasurer out of any money in the State Treasury to the 81 credit of the proper fund or funds as set forth in this act, upon warrants issued by the State Fiscal Officer; and the State Fiscal 82 Officer shall issue his warrants upon requisitions signed by the 83 proper person, officer or officers, in the manner provided by law. 84 SECTION 5. This act shall take effect and be in force from 85 and after July 1, 2005. 86
