Senate Amendments to House Bill No. 1661

TO THE CLERK OF THE HOUSE:

THIS IS TO INFORM YOU THAT THE SENATE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:

AMENDMENT NO. 1

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

5	SECTION 1. The following sum, or so much thereof as may be
6	necessary, is hereby appropriated out of any money in any special
7	fund in the State Treasury to the credit of the Mississippi
8	Department of Insurance which is comprised of special source funds
9	collected by or otherwise available to the department, for the
10	purpose of defraying the expenses of the department for the fiscal
11	year beginning July 1, 2005, and ending June 30, 2006
12	\$ 6,744,500.00.
13	SECTION 2. Of the funds appropriated under the provisions of
14	Section 1, not more than the amounts set forth below shall be
15	expended for the respective major objects or purposes of
16	expenditure:

33	With the funds herein appropriated, it is the intention of
34	the Legislature that it shall be the agency's responsibility to
35	make certain that funds required to be appropriated for "Personal
36	Services" for Fiscal Year 2007 do not exceed Fiscal Year 2006
37	funds appropriated for that purpose, unless programs or positions
38	are added to the agency's Fiscal Year 2007 budget by the
39	Mississippi Legislature. Based on data provided by the
40	Legislative Budget Office, the State Personnel Board shall
41	determine and publish the projected annual cost to fully fund all
42	appropriated positions in compliance with the provisions of this
43	act. It shall be the responsibility of the agency head to insure
44	that no single personnel action increases this projected annual
45	cost and/or the Fiscal Year 2006 appropriation for "Personal
46	Services" when annualized, with the exception of escalated funds.
47	If, at the time the agency takes any action to change "Personal
48	Services," the State Personnel Board determines that the agency
49	has taken an action which would cause the agency to exceed this
50	projected annual cost or the Fiscal Year 2006 "Personal Services"
51	appropriated level, when annualized, then only those actions which
52	reduce the projected annual cost and/or the appropriation
53	requirement will be processed by the State Personnel Board until
54	such time as the requirements of this provision are met.
55	Any transfers or escalations shall be made in accordance with
56	the terms, conditions and procedures established by law or
57	allowable under the terms set forth within this act. The State
58	Personnel Board shall not escalate positions without written
59	approval from the Department of Finance and Administration. The
60	Department of Finance and Administration shall not provide written
61	approval to escalate any funds for salaries and/or positions
62	without proof of availability of new or additional funds above the
63	appropriated level.
64	No general funds authorized to be expended herein shall be

used to replace federal funds and/or other special funds which are

- 66 being used for salaries authorized under the provisions of this
- 67 act and which are withdrawn and no longer available.
- 68 **SECTION 3.** It is the intention of the Legislature that the
- 69 Mississippi Department of Insurance shall maintain complete
- 70 accounting and personnel records related to the expenditure of all
- 71 funds appropriated under this act and that such records shall be
- 72 in the same format and level of detail as maintained for Fiscal
- 73 Year 2005. It is further the intention of the Legislature that
- 74 the agency's budget request for Fiscal Year 2007 shall be
- 75 submitted to the Joint Legislative Budget Committee in a format
- 76 and level of detail comparable to the format and level of detail
- 77 provided during the Fiscal Year 2006 budget request process.
- 78 **SECTION 4.** Of the funds appropriated under the provisions of
- 79 Section 1, and authorized for expenditure in Section 2, Sixteen
- 80 Thousand Four Hundred Fifty-one Dollars (\$16,451.00) is provided
- 81 for the Mississippi Fire Personnel Minimum Standards and
- 82 Certification Board.
- 83 **SECTION 5.** The following sum, or so much thereof as may be
- 84 necessary, is hereby appropriated out of any money in the special
- 85 fund in the State Treasury to the credit of the Rural Fire Truck
- 86 Acquisition Fund to the Mississippi Department of Insurance for
- 87 the Rural Fire Truck Acquisition Assistance Program for the fiscal
- 98 year beginning July 1, 2005, and ending June 30, 2006.....
- 89\$ 1,700,000.00.
- 90 **SECTION 6.** Of the funds appropriated under the provisions of
- 91 Section 1 and authorized for expenditure in Section 2, funds in
- 92 the amount of Ten Thousand Dollars (\$10,000.00) are provided and
- 93 shall be expended to pay the annual dues for the National
- 94 Conference of Insurance Legislators.
- 95 **SECTION 7.** The money herein appropriated shall be paid
- 96 by the State Treasurer out of any money in the State Treasury to
- 97 the credit of the proper fund or funds as set forth in this act,
- 98 upon warrants issued by the State Fiscal Officer; and the State
- 99 Fiscal Officer shall issue his warrants upon requisitions signed

- 100 by the proper person, officer or officers, in the manner provided
- 101 by law.
- SECTION 8. This act shall take effect and be in force from 102
- 103 and after July 1, 2005.
