With the funds herein appropriated, it is the intention of 31 the Legislature that it shall be the agency's responsibility to 32 make certain that funds required to be appropriated for "Personal 33 34 Services" for Fiscal Year 2007 do not exceed Fiscal Year 2006 funds appropriated for that purpose, unless programs or positions 35 36 are added to the agency's Fiscal Year 2007 budget by the 37 Mississippi Legislature. Based on data provided by the 38 Legislative Budget Office, the State Personnel Board shall determine and publish the projected annual cost to fully fund all 39 40 appropriated positions in compliance with the provisions of this 41 It shall be the responsibility of the agency head to insure act. that no single personnel action increases this projected annual 42 43 cost and/or the Fiscal Year 2006 appropriation for "Personal Services" when annualized, with the exception of escalated funds. 44 45 If, at the time the agency takes any action to change "Personal Services," the State Personnel Board determines that the agency 46 47 has taken an action which would cause the agency to exceed this 48 projected annual cost or the Fiscal Year 2006 "Personal Services" appropriated level, when annualized, then only those actions which 49 50 reduce the projected annual cost and/or the appropriation requirement will be processed by the State Personnel Board until 51 52 such time as the requirements of this provision are met.

53 Any transfers or escalations shall be made in accordance with 54 the terms, conditions and procedures established by law or 55 allowable under the terms set forth within this act. The State

56 Personnel Board shall not escalate positions without written 57 approval from the Department of Finance and Administration. The 58 Department of Finance and Administration shall not provide written 59 approval to escalate any funds for salaries and/or positions 60 without proof of availability of new or additional funds above the 61 appropriated level.

No general funds authorized to be expended herein shall be used to replace federal funds and/or other special funds which are being used for salaries authorized under the provisions of this act and which are withdrawn and no longer available.

66 SECTION 3. It is the intention of the Legislature that the Mississippi Athletic Commission shall maintain complete accounting 67 68 and personnel records related to the expenditure of all funds appropriated under this act and that such records shall be in the 69 same format and level of detail as maintained for Fiscal Year 70 71 2005. It is further the intention of the Legislature that the agency's budget request for Fiscal Year 2007 shall be submitted to 72 73 the Joint Legislative Budget Committee in a format and level of 74 detail comparable to the format and level of detail provided during the Fiscal Year 2006 budget request process. 75

SECTION 4. The money herein appropriated shall be paid by 76 77 the State Treasurer out of any money in the State Treasury to the credit of the proper fund or funds as set forth in this act, upon 78 warrants issued by the State Fiscal Officer; and the State Fiscal 79 80 Officer shall issue his warrants upon requisitions signed by the proper person, officer or officers, in the manner provided by law. 81 82 SECTION 5. This act shall take effect and be in force from 83 and after July 1, 2005.
