SECTION 3. It is the intention of the Legislature that the 31 Mississippi State Board of Psychology shall maintain complete 32 accounting and personnel records related to the expenditure of all 33 34 funds appropriated under this act and that such records shall be in the same format and level of detail as maintained for Fiscal 35 Year 2005. It is further the intention of the Legislature that 36 37 the agency's budget request for Fiscal Year 2007 shall be 38 submitted to the Joint Legislative Budget Committee in a format 39 and level of detail comparable to the format and level of detail provided during the Fiscal Year 2006 budget request process. 40 41 **SECTION 4.** The money herein appropriated shall be paid by the State Treasurer out of any money in the State Treasury to the 42 43 credit of the proper fund or funds as set forth in this act, upon warrants issued by the State Fiscal Officer; and the State Fiscal 44 45 Officer shall issue his warrants upon requisitions signed by the proper person, officer or officers, in the manner provided by law. 46 SECTION 5.
