32	the Legislature that it shall be the agency's responsibility to			
33	make certain that funds required to be appropriated for "Personal			
34	Services" for Fiscal Year 2007 do not exceed Fiscal Year 2006			
35	funds appropriated for that purpose, unless programs or positions			
36	are added to the ag	gency's Fiscal Year 2007 budget l	by the	
37	Mississippi Legislature. Based on data provided by the			
38	Legislative Budget Office, the State Personnel Board shall			
39	determine and publish the projected annual cost to fully fund all			
40	appropriated positions in compliance with the provisions of this			
41	act. It shall be the responsibility of the agency head to insure			
42	that no single personnel action increases this projected annual			
43	cost and/or the Fiscal Year 2006 appropriation for "Personal			
44	Services" when annualized, with the exception of escalated funds.			
45	If, at the time the	e agency takes any action to char	nge "Personal

- No general funds authorized to be expended herein shall be

- 66 **SECTION 3.** It is the intention of the Legislature that the
- 67 State Board of Agricultural Aviation shall maintain complete
- 68 accounting and personnel records related to the expenditure of all
- 69 funds appropriated under this act and that such records shall be
- 70 in the same format and level of detail as maintained for Fiscal
- 71 Year 2005. It is further the intention of the Legislature that
- 72 the agency's budget request for Fiscal Year 2007 shall be
- 73 submitted to the Joint Legislative Budget Committee in a format
- 74 and level of detail comparable to the format and level of detail
- 75 provided during the Fiscal Year 2006 budget request process.
- 76 **SECTION 4.** It is the intention of the Legislature that the
- 77 State Board of Agricultural Aviation is hereby authorized to
- 78 accept, budget and expend funds from donations, grants and any
- 79 special source funds in accordance with rules and regulations of
- 80 the Department of Finance and Administration in a manner
- 81 consistent with the escalation of federal funds.
- 82 **SECTION 5.** The money herein appropriated shall be paid by
- 83 the State Treasurer out of any money in the State Treasury to the
- 84 credit of the proper fund or funds as set forth in this act, upon
- 85 warrants issued by the State Fiscal Officer; and the State Fiscal
- 86 Officer shall issue his warrants upon requisitions signed by the
- 87 proper person, officer or officers, in the manner provided by law.
