32 With the funds herein appropriated, it is the intention of 33 the Legislature that it shall be the agency's responsibility to 34 make certain that funds required to be appropriated for "Personal 35 Services" for Fiscal Year 2007 do not exceed Fiscal Year 2006 36 funds appropriated for that purpose, unless programs or positions 37 are added to the agency's Fiscal Year 2007 budget by the Mississippi Legislature. Based on data provided by the 38 39 Legislative Budget Office, the State Personnel Board shall 40 determine and publish the projected annual cost to fully fund all 41 appropriated positions in compliance with the provisions of this It shall be the responsibility of the agency head to insure 42 act. 43 that no single personnel action increases this projected annual 44 cost and/or the Fiscal Year 2006 appropriation for "Personal 45 Services" when annualized, with the exception of escalated funds. If, at the time the agency takes any action to change "Personal 46 Services," the State Personnel Board determines that the agency 47 48 has taken an action which would cause the agency to exceed this projected annual cost or the Fiscal Year 2006 "Personal Services" 49 50 appropriated level, when annualized, then only those actions which reduce the projected annual cost and/or the appropriation 51 52 requirement will be processed by the State Personnel Board until such time as the requirements of this provision are met. 53 54 Any transfers or escalations shall be made in accordance with

55 the terms, conditions and procedures established by law or

allowable under the terms set forth within this act. The State Personnel Board shall not escalate positions without written approval from the Department of Finance and Administration. The Department of Finance and Administration shall not provide written approval to escalate any funds for salaries and/or positions without proof of availability of new or additional funds above the appropriated level.

No general funds authorized to be expended herein shall be used to replace federal funds and/or other special funds which are being used for salaries authorized under the provisions of this act and which are withdrawn and no longer available.

67 SECTION 3. None of the funds herein appropriated by this act 68 to the Public Service Commission shall be expended for any purpose 69 that is not actually required or necessary for performing any of 70 the powers or duties of the Mississippi Public Service Commission 71 that are authorized by the Mississippi Constitution of 1890, state 72 or federal law, or rules or regulations that implement state or 73 federal law.

74 It is the intention of the Legislature that the SECTION 4. 75 Public Service Commission shall maintain complete accounting and 76 personnel records related to the expenditure of all funds 77 appropriated under this act and that such records shall be in the same format and level of detail as maintained for Fiscal Year 78 2005. It is further the intention of the Legislature that the 79 80 agency's budget request for Fiscal Year 2007 shall be submitted to the Joint Legislative Budget Committee in a format and level of 81 82 detail comparable to the format and level of detail provided during the Fiscal Year 2006 budget request process. 83

84 SECTION 5. In addition to all other sums herein 85 appropriated, the following sum, or so much thereof as may be 86 necessary, is appropriated out of any money in the State Treasury 87 to the credit of the Public Service Commission, for the purpose of

defraying the expenses of the Public Service Commission to 88 administer the Mississippi Telephone Solicitation Act, for the 89 fiscal year beginning July 1, 2005, and ending June 30, 2006..... 90 91 .....\$ 160,000.00. 92 SECTION 6. The money herein appropriated shall be paid by the State Treasurer out of any money in the State Treasury to the 93 94 credit of the proper fund or funds as set forth in this act, upon warrants issued by the State Fiscal Officer; and the State Fiscal 95 Officer shall issue his warrants upon requisitions signed by the 96 proper person, officer or officers, in the manner provided by law. 97 SECTION 7. This act shall take effect and be in force from 98 99 and after July 1, 2005.
