## Amend by striking all after the enacting clause and inserting in lieu thereof the following:

5	SECTION 1. The following sum, or so much thereof as may be
6	necessary, is hereby appropriated out of any money in the State

9	Counsel of the State of Mississippi for the fiscal year beginning
10	July 1, 2005, and ending June 30, 2006\$ 656,992.00.
11	SECTION 2. Of the funds appropriated under the provisions of
12	Section 1, not more than the amounts set forth below shall be
13	expended for the respective major objects or purposes of
14	expenditure:

31 Any transfers or escalations shall be made in accordance with 32 the terms, conditions, and procedures established by law.

No general funds authorized to be expended herein shall be used to replace federal funds and/or other special funds which are being used for salaries authorized under the provisions of this act and which are withdrawn and no longer available.

37 SECTION 3. It is the intention of the Legislature that the Office of Capital Post-Conviction Counsel shall maintain complete 38 accounting and personnel records related to the expenditure of all 39 40 funds appropriated under this act and that such records shall be 41 in the same format and level of detail as maintained for Fiscal Year 2005. It is further the intention of the Legislature that 42 43 the agency's budget request for Fiscal Year 2007 shall be submitted to the Joint Legislative Budget Committee in a format 44 45 and level of detail comparable to the format and level of detail provided during the Fiscal Year 2006 budget request process. 46

SECTION 4. It is the intention of the Legislature that the 47 48 Office of Capital Post-Conviction Counsel shall have the authority to accept, budget and expend any source funds not to exceed Two 49 50 Million Dollars (\$2,000,000.00). Such funds are to be escalated in accordance with procedures for federal fund escalations as 51 established in Section 27-104-21, Mississippi Code of 1972, and 52 expended for the purposes of performing such duties as set forth 53 54 by law in accordance with applicable rules and regulations of the 55 State Fiscal Officer.

56 SECTION 5. The money herein appropriated shall be paid by the State Treasurer out of any money in the State Treasury to the 57 58 credit of the proper fund or funds as set forth in this act, upon warrants issued by the State Fiscal Officer; and the State Fiscal 59 Officer shall issue his warrants upon requisitions signed by the 60 proper person, officer or officers, in the manner provided by law. 61 SECTION 6. This act shall take effect and be in force from 62 63 and after July 1, 2005.
