## Adopted COMMITTEE AMENDMENT NO 1 PROPOSED TO

## House Bill No. 1648

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

5	<b>SECTION 1.</b> The following sum, or so much thereof as may be

12	SECTION 2. The following sum, or so much thereof as may be
13	necessary, is hereby appropriated out of any money in the special
14	fund in the State Treasury to the credit of the Mississippi
15	Library Commission which is comprised of special source funds
16	collected by or otherwise available to the commission, for the
17	purpose of defraying the expenses of the commission for the fiscal
18	year beginning July 1, 2005, and ending June 30, 2006
19	\$ 2,444,273.00.
20	SECTION 3. Of the funds appropriated under the provisions of
21	Section 1 and Section 2, not more than the amounts set forth below
22	shall be expended for the respective major objects or purposes of
23	expenditure:

- 58 If, at the time the agency takes any action to change "Personal
- 59 Services, " the State Personnel Board determines that the agency
- 60 has taken an action which would cause the agency to exceed this
- 61 projected annual cost or the Fiscal Year 2006 "Personal Services"
- 62 appropriated level, when annualized, then only those actions which
- 63 reduce the projected annual cost and/or the appropriation

- Any transfers or escalations shall be made in accordance with

- 71 Department of Finance and Administration shall not provide written
- 72 approval to escalate any funds for salaries and/or positions
- 73 without proof of availability of new or additional funds above the
- 74 appropriated level.
- 75 No general funds authorized to be expended herein shall be
- 76 used to replace federal funds and/or other special funds which are
- 77 being used for salaries authorized under the provisions of this
- 78 act and which are withdrawn and no longer available.
- 79 Funds to be distributed to eligible public library systems
- 80 under the Personnel Incentive Grants Program shall be paid
- 81 quarterly in advance on or before September 30, December 31, March
- 82 31 and June 30.
- 83 **SECTION 4.** It is the intention of the Legislature that the
- 84 Mississippi Library Commission shall maintain complete accounting
- 85 and personnel records related to the expenditure of all funds
- 86 appropriated under this act and that such records shall be in the
- 87 same format and level of detail as maintained for Fiscal Year

98	SECTION 6. In compliance with the "Mississippi	Performance
99	Budget and Strategic Planning Act of 1994," it is the	e intent of
100	the Legislature that the funds provided herein shall	be utilized
101	in the most efficient and effective manner possible	to achieve the
102	intended mission of this agency. Based on the fundi	ng authorized,
103	this agency shall make every effort to attain the tax	rgeted

121	agency's budget request submitted to the Joint Legislative Budget
122	Committee for Fiscal Year 2007.
123	SECTION 7. It is the intention of the Legislature that the
124	Mississippi Library Commission shall have the authority to
125	escalate its budget and expend funds from any source not to exceed
126	Three Million Dollars (\$3,000,000.00) in accordance with rules and
127	regulations of the Department of Finance and Administration in a
128	manner consistent with the escalation of federal funds.
129	SECTION 8. Of the funds appropriated herein, not less than
130	One Million Eighty-six Thousand Three Hundred Forty Dollars
131	(\$1,086,340.00) shall be expended for the Magnolia Database.
132	SECTION 9. The money herein appropriated shall be paid by
133	the State Treasurer out of any money in the State Treasury to the
134	credit of the proper fund or funds as set forth in this act, upon
135	warrants issued by the State Fiscal Officer; and the State Fiscal
136	Officer shall issue his warrants upon requisitions signed by the
137	proper person, officer or officers, in the manner provided by law.

and after July 1, 2005.
