AMENDMENT NO 1 PROPOSED TO**

1 **AMEND by inserting the following new section after line 395**
2 **and renumbering subsequent sections accordingly:**

3 **SECTION *.** Section 29-5-77, Mississippi Code of 1972, is
4 amended as follows:

5 29-5-77. The Department of Finance and Administration shall
6 have jurisdiction relative to the enforcement of all laws of the
7 State of Mississippi on the properties set forth in Section
8 29-5-2, the Court of Appeals Building, the Mississippi Department
9 of Transportation Building and the Public Employees' Retirement
10 System Building. The Department of Finance and Administration
11 shall, through any person or persons appointed by the Department
12 of Finance and Administration, or through the Department of Public
13 Safety when requested by the Department of Finance and
14 Administration, make arrests for any violation of any law of the
15 State of Mississippi on those grounds of or within those
16 properties. The Department of Finance and Administration shall
17 enforce the provisions of Sections 29-5-57 through 29-5-67,
18 29-5-71 through 29-5-77, and 29-5-81 through 29-5-95, and
19 prescribe such rules and regulations as are necessary therefor.

20 When in the opinion of the Governor or, in his absence, the
21 Lieutenant Governor, it is readily apparent that an emergency
22 exists that the persons appointed by the Department of Finance and
23 Administration are unable to control in the accomplishment of the

24 provisions of Sections 29-5-57 through 29-5-67, 29-5-71 through
25 29-5-77, and 29-5-81 through 29-5-95 in regard to law enforcement,
26 then the Governor, or in his absence, the Lieutenant Governor, may
27 call upon the Department of Public Safety, members of which shall
28 have power to arrest and detain any persons violating the
29 provisions of those sections of law, until the person can be
30 brought before the proper authorities for trial.

31 Subject to the approval of the Board of Trustees of State
32 Institutions of Higher Learning, the Board of Trustees and the
33 Department of Finance and Administration shall be authorized to
34 enter into a contract for the Department of Finance and
35 Administration to supply the security personnel with jurisdiction
36 relative to the enforcement of all laws of the State of
37 Mississippi on the property of the Board of Trustees located at
38 the corner of Ridgewood Road and Lakeland Drive in the City of
39 Jackson.

40 **FURTHER, amend the title by inserting the following after the**
41 **semicolon on line 9:**

42 TO AMEND SECTION 29-5-77, MISSISSIPPI CODE OF 1972, TO AUTHORIZE
43 THE DEPARTMENT OF FINANCE AND ADMINISTRATION TO ENFORCE LAWS ON
44 CERTAIN PROPERTY OF THE BOARD OF TRUSTEES OF STATE INSTITUTIONS OF
45 HIGHER LEARNING;
