4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
5	SECTION 1. The following sum, or so much thereof as may be
6	necessary, is hereby appropriated out of any money in the special
7	fund in the State Treasury to the credit of the State Board of
8	Agricultural Aviation, for the purpose of defraying the expenses
9	of the board for the fiscal year beginning July 1, 2005, and
10	ending June 30, 2006\$ 163,681.00.
11	SECTION 2. With the funds appropriated under the provisions
12	of Section 1, the following positions are authorized:

14	Permanent: Full Time 2

16	Time-Limited: Full Time 0

18	With the funds herein appropriated, it is the intention of
19	the Legislature that it shall be the agency's responsibility to
20	make certain that funds required to be appropriated for "Personal
21	Services" for Fiscal Year 2007 do not exceed Fiscal Year 2006
22	funds appropriated for that purpose, unless programs or positions
23	are added to the agency's Fiscal Year 2007 budget by the
24	Mississippi Legislature. Based on data provided by the
25	Legislative Budget Office, the State Personnel Board shall
26	determine and publish the projected annual cost to fully fund all
27	appropriated positions in compliance with the provisions of this

- 61 Accountant License or higher level professional certification as
- 62 determined by the State Personnel Board, the immediate replacement
- of a departing employee with an individual from within state
- 64 service or a new hire at a salary level equivalent to that of the
- 65 departing employee, and the emergency appointment of nurses,
- 66 pharmacists or other health care professionals at a salary to be
- 67 determined by the State Personnel Board, unless otherwise

- 69 **SECTION 3.** It is the intention of the Legislature that the
- 70 State Board of Agricultural Aviation shall maintain complete

- 83 the Department of Finance and Administration in a manner
- 84 consistent with the escalation of federal funds.
- 85 **SECTION 5.** None of the monies appropriated under this act
- 86 shall be expended for payment of that amount of the salary of any
- 87 person holding the position of division director, department
- 88 director or head, bureau director, deputy or assistant director or
- 89 similar position on May 15, 2005, which would exceed the amount
- 90 actually paid for the same position on June 30, 2003, regardless
- 91 of the title or position held or duties performed by the person
- 92 holding the position on June 30, 2003.

SECTION 6. The money herein appropriated shall be paid by 93 the State Treasurer out of any money in the State Treasury to the 94 credit of the proper fund or funds as set forth in this act, upon 95 warrants issued by the State Fiscal Officer; and the State Fiscal 96 97 Officer shall issue his warrants upon requisitions signed by the proper person, officer or officers, in the manner provided by law. 98 99 **SECTION** 7. This act shall take effect and be in force from and after July 1, 2005. 100
