AN ACT APPROVING THE EXPENDITURE OF SPECIAL FUNDS FOR THE 1 PURPOSE OF DEFRAYING THE EXPENSES OF THE MISSISSIPPI COAST 2 3 COLISEUM COMMISSION FOR THE FISCAL YEAR 2006. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 4 SECTION 1. The following sum, or so much thereof as may be 5 necessary, is hereby authorized and approved for expenditure out 6 7 of any funds which are received by or otherwise become available 8 to the Mississippi Coast Coliseum Commission, for the purpose of defraying expenses of the commission for the fiscal year beginning 9 July 1, 2005, and ending June 30, 2006..... 10 .....\$ 4,126,585.00. 11 12 SECTION 2. 32 Any transfers or escalations shall be made in accordance with 33 the terms, conditions and procedures established by law.

No general funds authorized to be expended herein shall be used to replace federal funds and/or other special funds which are being used for salaries authorized under the provisions of this act and which are withdrawn and no longer available.

38 SECTION 3. It is the intention of the Legislature that the Mississippi Coast Coliseum Commission shall maintain complete 39 40 accounting and personnel records related to the expenditure of all funds appropriated under this act and that such records shall be 41 in the same format and level of detail as maintained for Fiscal 42 Year 2005. It is further the intention of the Legislature that 43 the agency's budget request for Fiscal Year 2007 shall be 44 45 submitted to the Joint Legislative Budget Committee in a format and level of detail comparable to the format and level of detail 46 47 provided during the Fiscal Year 2006 budget request process.

48 **SECTION 4.** The money herein approved for expenditure shall 49 be disbursed upon bank checks signed by the proper person, officer 50 or officers, in the manner provided by law.

51 **SECTION 5.** This act shall take effect and be in force from 52 and after July 1, 2005.
