6	SECTION 1. The following sum, or so much thereof as may be
7	necessary, is hereby appropriated out of any money in the State
8	General Fund not otherwise appropriated, for the purpose of paying
9	salaries and travel expenses of district attorneys and assistant
10	district attorneys of the state and paying office expenses of
11	district attorneys for the fiscal year beginning July 1, 2005, and
12	ending June 30, 2006\$ 15,612,928.00.
13	SECTION 2. The following sum, or so much thereof as may be
14	necessary, is hereby appropriated out of any money in the State
15	Prosecutor Compensation Fund, referred to in Section 99-19-73,
16	Mississippi Code of 1972, for the purpose of paying salaries of
17	assistant district attorneys of the state as authorized in Section
18	25-31-5(1) for the fiscal year beginning July 1, 2005 and ending
19	June 30, 2006\$ 546,750.00.
20	SECTION 3. Of the funds appropriated under the provisions of

35	SECTION 4. Of the funds appropriated in Section 1, office
36	expenses and such funds for salaries shall be provided as
37	authorized in Section 25-3-35(6), Mississippi Code of 1972, to
38	fund the salary for one (1) full-time legal assistant in the Sixth
39	Circuit Court District as authorized in Section 25-31-5(2)(f),

11	SECTION 5. The money herein appropriated shall be paid by
