## HOUSE BILL NO. 84

AN ACT MAKING AN APPROPRIATION FROM SPECIAL FUNDS IN THE 1 STATE TREASURY FOR THE PURPOSE OF DEFRAYING THE EXPENSES OF THE 2 3 STATE BOARD OF MEDICAL LICENSURE FOR THE FISCAL YEAR 2006. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 4 SECTION 1. The following sum, or so much thereof as may be 5 necessary, is hereby appropriated out of any money in the special 6 7 fund in the State Treasury to the credit of the State Board of 8 Medical Licensure, for the purpose of defraying the expenses of the board for the fiscal year beginning July 1, 2005, and ending 9 June 30, 2006.....\$ 2,065,866.00. 10 SECTION 2. Of the funds appropriated under the provisions of 11 Section 1, not more than the amounts set forth below shall be 12 13 expended for the respective major objects or purposes of expenditure: 14 MAJOR OBJECTS OF EXPENDITURE: 15 16 Personal Services: Salaries, Wages and Fringe Benefits.. \$ 17 999,148.00 18 Travel and Subsistence..... 28,000.00 Contractual Services..... 19 745,368.00 20 Commodities..... 53,350.00 21 Capital Outlay: 0.00 22 Other Than Equipment..... 40,000.00 23 Equipment..... 31 With the funds herein appropriated, it is the intention of 32 the Legislature that it shall be the agency's responsibility to 33 make certain that funds required to be appropriated for "Personal Services" for Fiscal Year 2007 do not exceed Fiscal Year 2006 34 35 funds appropriated for that purpose, unless programs or positions are added to the agency's Fiscal Year 2007 budget by the 36 37 Mississippi Legislature. Based on data provided by the 38 Legislative Budget Office, the State Personnel Board shall determine and publish the projected annual cost to fully fund all 39 40 appropriated positions in compliance with the provisions of this 41 It shall be the responsibility of the agency head to insure act. 42 that no single personnel action increases this projected annual cost and/or the Fiscal Year 2006 appropriation for "Personal 43 44 Services" when annualized, with the exception of escalated funds. If, at the time the agency takes any action to change "Personal 45 Services," the State Personnel Board determines that the agency 46 47 has taken an action which would cause the agency to exceed this projected annual cost or the Fiscal Year 2006 "Personal Services" 48 49 appropriated level, when annualized, then only those actions which reduce the projected annual cost and/or the appropriation 50 51 requirement will be processed by the State Personnel Board until 52 such time as the requirements of this provision are met.

Any transfers or escalations shall be made in accordance with the terms, conditions and procedures established by law or allowable under the terms set forth within this act. The State Personnel Board shall not escalate positions without written approval from the Department of Finance and Administration. The Department of Finance and Administration shall not provide written approval to escalate any funds for salaries and/or positions

No general funds authorized to be expended herein shall be used to replace federal funds and/or other special funds which are being used for salaries authorized under the provisions of this act and which are withdrawn and no longer available.

66 The agency shall not take any action to promote or otherwise 67 award salary increases through reallocation, reclassification, realignment, education benchmark, career ladder, or any other 68 69 means to increase salaries of employees or positions unless 70 specifically exempted by the following conditions: the award of teacher pay increases, the advancement of a trainee/cadet to the 71 72 next level of a bona fide career ladder, the award of an educational benchmark for the attainment of Certified Public 73 74 Accountant License or higher level professional certification as determined by the State Personnel Board, the immediate replacement 75 76 of a departing employee with an individual from within state 77 service or a new hire at a salary level equivalent to that of the departing employee, and the emergency appointment of nurses, 78 79 pharmacists or other health care professionals at a salary to be 80 determined by the State Personnel Board, unless otherwise 81 authorized in this act.

SECTION 3. It is the intention of the Legislature that the 82 83 State Board of Medical Licensure shall maintain complete 84 accounting and personnel records related to the expenditure of all funds appropriated under this act and that such records shall be 85 86 in the same format and level of detail as maintained for Fiscal Year 2005. It is further the intention of the Legislature that 87 the agency's budget request for Fiscal Year 2007 shall be 88 submitted to the Joint Legislative Budget Committee in a format 89 90 and level of detail comparable to the format and level of detail 91 provided during the Fiscal Year 2006 budget request process.

Of the funds provided herein, the sum of 93 Seventy-six Thousand Eight Hundred Thirty-one Dollars (\$76,831.00) 94 is hereby assessed on any nonfederal special funds and shall be 95 deposited to the Budget Contingency Fund created in Section 96 27-103-301, Mississippi Code of 1972, on or before October 1, 97 2005, for the purpose of reimbursing the State of Mississippi for 98 administrative costs.

99 SECTION 5. The money herein appropriated shall be paid by 100 the State Treasurer out of any money in the State Treasury to the credit of the proper fund or funds as set forth in this act, upon 101 102 warrants issued by the State Fiscal Officer; and the State Fiscal 103 Officer shall issue his warrants upon requisitions signed by the 104 proper person, officer or officers, in the manner provided by law. 105 SECTION 6. This act shall take effect and be in force from and after July 1, 2005. 106
