AN ACT APPROVING THE EXPENDITURE OF SPECIAL FUNDS FOR THE 1 PURPOSE OF DEFRAYING THE EXPENSES OF THE YELLOW CREEK STATE INLAND 2 3 PORT AUTHORITY FOR THE FISCAL YEAR 2006. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 4 SECTION 1. The following sum, or so much thereof as may be 5 necessary, is hereby authorized and approved for expenditure out 6 7 of any funds which are received by or otherwise become available 8 to the Yellow Creek State Inland Port Authority, for the purpose of defraying the expenses of the Authority for the fiscal year 9 beginning July 1, 2005, and ending June 30, 2006..... 10 \$ 6,723,558.00. 11 SECTION 2. Of the funds appropriated under the provisions of 12 13 Section 1, not more than the amounts set forth below shall be expended for the respective major objects or purposes of 14 15 expenditure: 16 MAJOR OBJECTS OF EXPENDITURE: Personal Services: 17 Salaries, Wages and Fringe Benefits.. \$ 18 593,908.00 Travel and Subsistence..... 19 20,000.00 20 Contractual Services..... 727,350.00 21 Commodities..... 65,300.00 22 Capital Outlay: 3,000,000.00 23 Other Than Equipment..... 1,817,000.00 24 Equipment..... 32 Any transfers or escalations shall be made in accordance with 33 the terms, conditions and procedures established by law.

No general funds authorized to be expended herein shall be used to replace federal funds and/or other special funds which are being used for salaries authorized under the provisions of this act and which are withdrawn and no longer available.

38 SECTION 3. It is the intention of the Legislature that the Yellow Creek State Inland Port Authority shall maintain complete 39 40 accounting and personnel records related to the expenditure of all funds appropriated under this act and that such records shall be 41 in the same format and level of detail as maintained for Fiscal 42 Year 2005. It is further the intention of the Legislature that 43 the agency's budget request for Fiscal Year 2007 shall be 44 45 submitted to the Joint Legislative Budget Committee in a format and level of detail comparable to the format and level of detail 46 47 provided during the Fiscal Year 2006 budget request process.

48 **SECTION 4.** The money herein approved for expenditure shall 49 be disbursed upon bank checks signed by the proper person, officer 50 or officers, in the manner provided by law.

51 **SECTION 5.** This act shall take effect and be in force from 52 and after July 1, 2005.
