4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI
5	SECTION 1. The following sum, or so much thereof as may be
6	necessary, is hereby appropriated out of any money in the State
7	Treasury to the credit of the State Board of Funeral Services for
8	the purpose of defraying the expenses of said board for the fiscal
9	year beginning July 1, 2005, and ending June 30, 2006
10	\$ 228,334.00
11	SECTION 2. With the funds appropriated under the provisions
12	of Section 1, the following positions are authorized:
13	AUTHORIZED POSITIONS:
14	Permanent: Full Time 2
15	Part Time 0
16	Time-Limited: Full Time 0

18	With the funds herein appropriated, it is the intention of
19	the Legislature that it shall be the agency's responsibility to
20	make certain that funds required to be appropriated for "Personal
21	Services" for Fiscal Year 2007 do not exceed Fiscal Year 2006
22	funds appropriated for that purpose, unless programs or positions
23	are added to the agency's Fiscal Year 2007 budget by the
24	Mississippi Legislature. Based on data provided by the
25	Legislative Budget Office, the State Personnel Board shall
26	determine and publish the projected annual cost to fully fund all
27	appropriated positions in compliance with the provisions of this

It shall be the responsibility of the agency head to insure

- 69 **SECTION 3.** Of the funds provided herein, the sum of Eight
- 70 Thousand Six Hundred Forty-one Dollars (\$8,641.00) is hereby
- 71 assessed on any non-federal special funds and shall be deposited
- 72 to the Budget Contingency Fund created in Section 27-103-301,
- 73 Mississippi Code of 1972, on or before October 1, 2005, for the
- 74 purpose of reimbursing the State of Mississippi for administrative
- 75 costs.
- 76 **SECTION 4.** It is the intention of the Legislature that the
- 77 Funeral Services Board shall maintain complete accounting and
- 78 personnel records related to the expenditure of all funds
- 79 appropriated under this act and that such records shall be in the
- 80 same format and level of detail as maintained for Fiscal Year
- 81 2005. It is further the intention of the Legislature that the
- 82 agency's budget request for Fiscal Year 2007 shall be submitted to
- 83 the Joint Legislative Budget Committee in a format and level of
- 84 detail comparable to the format and level of detail provided
- 85 during the Fiscal Year 2006 budget request process.
- SECTION 5. The money herein appropriated shall be paid by
- 87 the State Treasurer out of any money in the State Treasury to the
- 88 credit of the proper fund or funds as set forth in this act, upon
- 89 warrants issued by the State Fiscal Officer; and the State Fiscal
- 90 Officer shall issue his warrants upon requisitions signed by the
- 91 proper person, officer or officers in the manner provided by law.
- 92 **SECTION 6.** This act shall take effect and be in force from
- 93 and after July 1, 2005.
