AN ACT MAKING AN APPROPRIATION TO THE TENNESSEE-TOMBIGBEE 1 WATERWAY DEVELOPMENT AUTHORITY FOR THE PURPOSES ENUMERATED IN 2 3 SECTION 51-27-1, MISSISSIPPI CODE OF 1972, FOR FISCAL YEAR 2006. 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: SECTION 1. The following sum, or so much thereof as may be 5 necessary, is hereby appropriated out of any money in the State 6 General Fund not otherwise appropriated, to the 7 8 Tennessee-Tombigbee Waterway Development Authority for the purposes enumerated in Section 51-27-1, Mississippi Code of 1972, 9 for the fiscal year beginning July 1, 2005, and ending 10 June 30, 2006.....\$ 78,758.00. 11 SECTION 2. The following sum, or so much thereof as may be 12 13 necessary, is hereby authorized for expenditure out of any special source funds which are collected by or otherwise become available 14 15 for the purpose of defraying the expenses of the 16 Tennessee-Tombigbee Waterway Development Authority for the fiscal year beginning July 1, 2005, and ending June 30, 2006..... 17 18 .....\$ 203,418.00. SECTION 3. No general funds authorized to be expended herein shall be used to replace federal funds and/or other special funds which are being used for salaries authorized under the provisions of this act and which are withdrawn and no longer available.

49 SECTION 4. It shall be unlawful for any officer, employee or 50 other person whatsoever to use or permit or authorize the use of 51 any automobile or any other motor vehicle owned by the State of 52 Mississippi or any department, agency or institution thereof for 53 any purpose other than upon the official business of the State of 54 Mississippi or any agency, department or institution thereof.

55 It is the intent of the Legislature that motor vehicles 56 authorized to be owned and operated by this agency shall comply 57 with Sections 25-1-77 through 25-1-93, Mississippi Code of 1972. 58 **SECTION 5.** The money herein appropriated shall be paid by
