SENATE CONCURRENT RESOLUTION NO. 503

1 A CONCURRENT RESOLUTION REMEMBERING THE GALLANT SERVICE AND

- 2 COMMENDING THE LIFE OF LANCE CORPORAL STEPHEN BALDWYN, 19, OF
- 3 EGGVILLE, MISSISSIPPI, WHO WAS A COMBAT CASUALTY IN IRAQ ON
- 4 SUNDAY, MAY 8, 2005, AND EXPRESSING THE SYMPATHY OF THE
- 5 LEGISLATURE.
- 6 WHEREAS, Lance Corporal Stephen Baldwyn, 19, of Eggville,
- 7 Mississippi, was killed on Sunday, May 8, 2005, while conducting
- 8 combat operations against enemy forces in Nassar Wa Salaam, Iraq;
- 9 and
- 10 WHEREAS, carried by a military honor guard, he came home to
- 11 his native community and family, and was buried with full military
- 12 honors on Tuesday, May 17, 2005, at Eggville Cemetery, with
- 13 Commander Robert Beede officiating; and
- 14 WHEREAS, Corporal Baldwyn was assigned to the 3rd Battalion,
- 15 8th Marine Regiment, 2nd Marine Division, II Marine Expeditionary
- 16 Force, based in Camp Lejeune, North Carolina. He was proud to
- 17 serve his country as a United States Marine; and
- 18 WHEREAS, he was born May 7, 1986. He was a 2004 graduate of
- 19 Mooreville High School, where he was active in the choral
- 20 department since eighth grade. He had received his Eagle Scout
- 21 Award from the Boy Scouts of America in January 2005. He was a
- 22 member of the Eggville Free Will Baptist Church. He enjoyed
- 23 playing tennis and golf, going camping, and spending time with his
- 24 dog, Chance; and
- WHEREAS, "He wanted to see the world," said his mother,
- 26 Stephanie Baldwyn, a veteran teacher at the high school. "He
- 27 wanted adventure"; and

- 28 WHEREAS, Corporal Baldwyn was stationed at Camp Geiger, North
- 29 Carolina, and was sent to Germany in January. At the end of
- 30 February, he was sent to Iraq; and
- 31 WHEREAS, since military operations in Afghanistan and Iraq
- 32 began, 28 soldiers with ties to Mississippi have died; and
- 33 WHEREAS, Mooreville High School recognized Baldwyn at the
- 34 playoff baseball game against Booneville High School; and
- 35 WHEREAS, survivors include his parents, Danny and Stephanie
- 36 Baldwyn of Eggville, Mississippi; sister, Angela Kaye Keith
- 37 (George), Shannon, Mississippi; brother, Allen Andrew Baldwyn
- 38 (Stephanie), Eggville, Mississippi; grandparents, Lorean Baldwyn
- 39 and Dottie Hale, both of Eggville, Mississippi; and two special
- 40 friends, Travis Brewer and Chance Reese; and
- 41 WHEREAS, to a country, a fallen soldier means a national
- 42 loss; to a community, a fallen soldier means a true hero; to a
- 43 parent, a fallen soldier means a son who will not be coming home.
- 44 Mississippians understand the costs of conflict because we have
- 45 paid them in the past, and it is with great pride and humility
- 46 that we recognize the heroic action of this great American and
- 47 Mississippian, who was the guardian of civilization as we know it
- 48 today:
- NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF
- 50 MISSISSIPPI, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN, That
- 51 we do hereby remember the gallant service and commend the life of
- 52 Lance Corporal Stephen Baldwyn of Eggville, Mississippi, who was
- 53 killed in action in Iraq on Sunday, May 8, 2005, and extend the
- 54 thoughts and prayers of the Legislature to his family and our
- 55 sorrow on his passing.
- BE IT FURTHER RESOLVED, That this resolution be presented to
- 57 the surviving family of Corporal Baldwyn and be made available to
- 58 members of the Capitol Press Corps.
