House Amendments to Senate Bill No. 2002

TO THE SECRETARY OF THE SENATE:

THIS IS TO INFORM YOU THAT THE HOUSE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:

AMENDMENT NO. 1

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

SECTION 1. In addition to all other sums heretofore appropriated, the following sum, or so much thereof as may be necessary, is hereby appropriated out of any money in the General Fund not otherwise appropriated, to defray the expenses of the Mississippi Department of Human Services, for the purpose of funding the general operating expenses of the department, for the fiscal year ending June 30, 2005...... \$ 5,000,000.00.

SECTION 2. In addition to all other sums heretofore appropriated, the following sum, or so much thereof as may be necessary, is hereby appropriated out of any money in the General Fund not otherwise appropriated, to defray the expenses of the Mississippi Department of Corrections, for the purpose of funding increased utility costs incurred by the department, for the fiscal year ending June 30, 2005...... \$ 11,142,622.00.

SECTION 3. In addition to all other sums heretofore appropriated, the following sum, or so much thereof as may be necessary, is hereby appropriated out of any money in the General Fund, not otherwise appropriated, for the purpose of making payments on bonds and interest on the full faith and credit bonds of the State of Mississippi falling due in the fiscal year ending June 30, 2005......\$ 16,000,000.00.

Of the funds appropriated in this section, the amount of Six Million Dollars (\$6,000,000.00) shall be used to reimburse the State General Fund for funds previously expended by the State Treasurer but not authorized by appropriation of the Legislature.

SECTION 4. In addition to all other sums heretofore 38 39 appropriated, the following sum, or so much thereof as may be necessary, is hereby appropriated out of any money in the State 40 41 Treasury which is comprised of special source funds for the purpose of making payments on bonds and interest on the full faith 42 43 and credit bonds of the State of Mississippi falling due in the fiscal year ending June 30, 2005.....\$ 6,000,000.00. 44 45 The funds appropriated in this section shall authorize the funds previously expended by the State Treasurer. 46

SECTION 5. In addition to all other sums heretofore appropriated, the following sum, or so much thereof as may be necessary, is hereby appropriated out of any money in the General Fund not otherwise appropriated, to defray the expenses of the Mississippi Department of Mental Health, for the purpose of funding Medicaid match at the community mental health centers\$ 2,000,000.00.

SECTION 6. In addition to all other sums heretofore 54 55 appropriated, the following sum, or so much thereof as may be 56 necessary, is hereby appropriated out of any money in the General Fund not otherwise appropriated, to defray the expenses of the 57 Office of the Attorney General, for the purpose of defraying the 58 59 costs of certain outside legal assistance, expert witness fees and court fees incurred by the Office of the Attorney General, for the 60 61 fiscal year ending June 30, 2005.....\$ 1,210,384.00. SECTION 15. The money herein appropriated shall be paid by the State Treasurer out of any money in the proper fund or funds as set forth in this act, upon warrants issued by the State Fiscal Officer; and the State Fiscal Officer shall issue his warrants upon requisitions signed by the proper person, officer or officers in the manner provided by law.

157 SECTION 16. This act shall take effect and be in force from 158 and after its passage.

Further, amend by striking the title in its entirety and inserting in lieu thereof the following:

AN ACT MAKING AN ADDITIONAL APPROPRIATION OF GENERAL AND 1 SPECIAL FUNDS TO DEFRAY THE EXPENSES OF THE FOLLOWING AGENCIES AND 2 3 OBLIGATIONS FOR FISCAL YEAR 2005: THE DEPARTMENT OF HUMAN 4 SERVICES, THE MISSISSIPPI DEPARTMENT OF CORRECTIONS, STATE OF 5 MISSISSIPPI BOND AND INTEREST PAYMENTS, THE DEPARTMENT OF MENTAL б HEALTH, THE OFFICE OF THE ATTORNEY GENERAL, THE DEPARTMENT OF FINANCE AND ADMINISTRATION, THE JUDICIAL PERFORMANCE COMMISSION, 7 8 THE OIL AND GAS BOARD, THE STATE DEPARTMENT OF HEALTH, THE PUBLIC SERVICE COMMISSION, THE BOARD OF DENTAL EXAMINERS, THE BOARD OF 9 10 PUBLIC CONTRACTORS, AND THE DEPARTMENT OF REHABILITATION SERVICES; 11 AND FOR RELATED PURPOSES.
