AN ACT MAKING AN ADDITIONAL APPROPRIATION OF GENERAL AND SPECIAL FUNDS TO DEFRAY THE EXPENSES OF THE FOLLOWING AGENCIES AND OBLIGATIONS FOR FISCAL YEAR 2005: THE DEPARTMENT OF HUMAN SERVICES, THE MISSISSIPPI DEPARTMENT OF CORRECTIONS, STATE OF MISSISSIPPI BOND AND INTEREST PAYMENTS, THE DEPARTMENT OF MENTAL HEALTH, THE OFFICE OF THE ATTORNEY GENERAL, THE DEPARTMENT OF FINANCE AND ADMINISTRATION, THE JUDICIAL PERFORMANCE COMMISSION, THE OIL AND GAS BOARD, THE STATE DEPARTMENT OF HEALTH, THE PUBLIC SERVICE COMMISSION, THE BOARD OF DENTAL EXAMINERS, THE BOARD OF PUBLIC CONTRACTORS, AND THE DEPARTMENT OF REHABILITATION SERVICES;
