- WHEREAS, Mrs. Lillian Doris (Wadlington) Carey of Lexington,
- 5 Mississippi, celebrated her 100th birthday on April 24, 2003; and
- 6 WHEREAS, Mrs. Carey was born on April 24, 1903, in the Gages
- 7 Springs Community (which is located 9 miles southeast of
- 8 Lexington) in Holmes County, Mississippi. She is the youngest of
- 9 11 children born to the union of Arthur and Anna Wadlington. Both
- 10 of Mrs. Carey's parents and all of her grandparents were slaves;
- 11 and
- 12 WHEREAS, Mrs. Carey, affectionately known as "Dee," married
- 13 Rev. Sam G. Carey, Sr. of Lexington, Mississippi, on August 23,
- 14 1927. To this union, the following five children were born: Sam
- 15 Jr., Doris Eileen, Roland, Howard and Gladys. Additionally, Mr.
- 16 and Mrs. Carey have 7 grandchildren and 11 great-grandchildren.
- 17 Rev. Carey, a faithful husband of 56 years, died in 1983 at the
- 18 age of 85. Besides obedience to God, nothing is more important to
- 19 Mrs. Carey than family, friends and neighbors; and
- 20 WHEREAS, she affiliated with Gages Springs Missionary Baptist
- 21 Church. After moving to Lexington, she joined Asia Baptist
- 22 Church, where she continues to hold membership; and
- 23 WHEREAS, Mrs. Carey received her high school diploma and
- 24 teaching certificate from Jackson College in 1926. In 1956, she
- 25 earned a B.S. degree from Jackson State College. She did
- 26 post-graduate study at Jackson State College (now Jackson State
- 27 University) and at Indiana University; and

- 28 WHEREAS, Mrs. Carey's professional career is as follows:
- 29 Hickory Springs Community School, 1926-1928; Lexington Elementary
- 30 School, four years during the 1930's; Ambrose Elementary/High
- 31 School, 1943-1959; and Lexington Attendance Center, 1959-1970.
- 32 Her total years spent as a public school teacher, before her
- 33 retirement on July 1, 1970, is 33 years; and
- 34 WHEREAS, Mrs. Carey holds membership in the following
- 35 organizations: Holmes County Retired Teachers Association;
- 36 Mississippi Retired Teachers Association; Mississippi Teachers
- 37 Association; National Education Association; Jackson State
- 38 University Alumni Association; National Council of Negro Women,
- 39 Inc.; President, R.C. Lee Federated Club of Lexington; Assistant
- 40 Secretary, State Federation of Colored Women's Clubs, Inc.;
- 41 Secretary, Standard Fraternal Aid Society; and (succeeded her
- 42 husband as committee-of-one) Pinkston Cemetery general upkeep; and
- WHEREAS, it is with pride that we recognize this landmark
- 44 event in the life of a Mississippian whose dedication to public
- 45 education, ministry of giving, political participation and local
- 46 community involvement stand as a model to the citizens in her
- 47 community and to the State of Mississippi:
- NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF
- 49 MISSISSIPPI, That we do hereby commend the educational service and
- 50 charitable commitment of Mrs. Lillian Doris (Wadlington) Carey on
- 51 the occasion of her 100th birthday on April 24, 2003, and extend
- 52 to her the best wishes of the Senate for her future health and
- 53 happiness.
