- 7 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF
- 8 MISSISSIPPI, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN:
- 9 (1) There is hereby created the Study Committee on a
- 10 Statewide Building Code, "committee." The purpose of the
- 11 committee is:
- 12 (a) To establish minimum standards for construction to
- 13 respond to federal requirements for the Federal Emergency
- 14 Management Agency (FEMA) aid after a natural disaster such as a
- 15 tornado, fire, earthquake or hurricane, specifically the Hurricane
- 16 Katrina disaster of 2005;
- 17 (b) To address concerns from national insurers who are
- 18 not renewing property insurance because of a lack of building
- 19 standards in many areas of Mississippi; and
- 20 (c) To promote the health, safety and welfare of the
- 21 public.
- 22 (2) The Study Committee on a Statewide Building Code shall
- 23 consist of the following members:
- 24 (a) The Executive Director of the State Board of
- 25 Architecture;
- 26 (b) The Executive Director of the State Board of Public
- 27 Contractors;
- 28 (c) The Executive Director of the State Board of
- 29 Registration for Professional Engineers and Land Surveyors;

- 30 (d) The Dean of the Mississippi State University School
- 31 of Architecture;
- 32 (e) The Dean of the Mississippi State University School
- 33 of Engineering;
- 34 (f) The Executive Director of the Bureau of Building,
- 35 Grounds and Real Property Management of the Department of Finance
- 36 and Administration;
- 37 (g) The State Fire Marshal;
- 38 (h) The Mississippi Commissioner of Insurance;
- 39 (i) The Executive Director of the Mississippi Emergency
- 40 Management Agency;
- 41 (j) One (1) member of the Mississippi State Senate,
- 42 appointed by the Lieutenant Governor;
- 43 (k) One (1) member of the Mississippi House of
- 44 Representatives, appointed by the Speaker of the House of
- 45 Representatives; and
- 46 (1) Two (2) citizen members, appointed by the Governor.
- 47 (3) The Executive Director of the State Board of
- 48 Architecture shall serve as the chairman of the committee.
- 49 (4) Nonlegislative members shall serve without salary or per
- 50 diem compensation; however, all members shall be entitled to
- 51 actual travel expenses as provided for in Section 25-3-41.
- 52 Legislative members shall be entitled to per diem, expense
- 53 allowance and mileage as authorized for committee meetings when
- 54 the Legislature is not in session.
- 55 (5) The committee shall develop a report to the Legislature
- and the Governor to be delivered no later than December 1, 2005.
- 57 This report shall address at a minimum:
- 58 (a) A survey of other states to determine the types of

- (c) A survey of the laws of other states and
- 65 jurisdictions, including professional standards of care for
- 66 architects, engineers, fabricators, contractors and builders,
- 67 regarding minimal construction standards;
- 68 (d) A determination of the capacity of existing
- 69 agencies, including municipal and county building officials, which
- 70 now handle administrative and enforcement issues, to administer a
- 71 statewide building code, or the necessity of creating new agencies
- 72 to administer such a code;
- 73 (e) A recommendation regarding permit fee structures or
- 74 other enforcement means that would off-set implementation costs;
- 75 (f) A recommendation regarding the exemption of
- 76 successful established building codes in local jurisdictions; and
- 77 (g) Any recommended legislation to implement the
- 78 recommendations of the committee.
- 79 (6) The chairman shall have the authority to request staff
- 80 support from any state agency enumerated in this resolution to
- 81 assist the task force in carrying out its responsibilities.
- 82 (7) Upon presentation of its final report, the committee
- 83 shall be dissolved.
