HOUSE BILL NO. 210

1 AN ACT MAKING AN APPROPRIATION TO THE DEPARTMENT OF MENTAL
2 HEALTH TO FULLY FUND THE OPERATION AND MAINTENANCE OF THE SEVEN
3 MENTAL HEALTH CRISIS CENTERS AND PROVIDE FUNDING FOR THE
4 SPECIALIZED TREATMENT FACILITY IN HARRISON COUNTY FOR FISCAL YEAR
5 2007.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

7 **SECTION 1.** The following sum, or so much of it as may be
8 necessary, is appropriated out of any money in the State General
9 Fund not otherwise appropriated, to the Department of Mental
10 Health for the operation and maintenance of the seven (7) mental
11 health crisis centers and the Specialized Treatment Facility in
12 Harrison County, for the fiscal year beginning July 1, 2006, and
13 ending June 30, 2007..... \$13,804,114.00.

14 **SECTION 2.** The following sum, or so much of it as may be
15 necessary, is appropriated out of the Health Care Expendable Fund
16 created in Section 43-13-407, Mississippi Code of 1972, to the
17 Department of Mental Health for the operation and maintenance of
18 the seven (7) mental health crisis centers for the fiscal year
19 beginning July 1, 2006, and ending June 30, 2007..... \$876,507.00.

20 **SECTION 3.** The following sum, or so much of it as may be
21 necessary, is appropriated out of the Crisis Intervention Mental
22 Health Fund created in Section 41-21-151, Mississippi Code of
23 1972, to the Department of Mental Health for the operation and
24 maintenance of the seven (7) mental health crisis centers for the
25 fiscal year beginning July 1, 2006, and ending June 30, 2007.....
26 \$4,382,540.00.

27 **SECTION 4.** With the funds appropriated under the provisions
28 of this act, the following positions are authorized:

33 **SECTION 5.** Of the funds appropriated in Section 1, it is the
34 intention of the Legislature that an amount not to exceed Eight
35 Hundred Thousand Dollars (\$800,000.00) shall be used for the
36 Specialized Treatment Facility in Harrison County.

37 **SECTION 6.** The money appropriated in this act shall be paid
38 by the State Treasurer out of any money in the State Treasury to
39 the credit of the proper fund or funds as set forth in this act,
40 upon warrants issued by the State Fiscal Officer; and the State
41 Fiscal Officer shall issue his warrants upon requisitions signed
42 by the proper person, officer or officers in the manner provided
43 by law.

44 **SECTION 7.** This act shall take effect and be in force from
45 and after July 1, 2006.
