## HOUSE BILL NO. 590

- 1 AN ACT TO AMEND SECTIONS 41-85-3 AND 41-85-7, MISSISSIPPI 2 CODE OF 1972, TO REVISE THE DEFINITION OF "HOSPICE" FOR FACILITY
- 3 LICENSURE PURPOSES TO CONFORM TO THE FEDERAL DEFINITION OF
- 4 TERMINALLY ILL; AND FOR RELATED PURPOSES.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 6 **SECTION 1.** Section 41-85-3, Mississippi Code of 1972, is
- 7 amended as follows:
- 8 41-85-3. When used in this chapter, unless the context
- 9 otherwise requires:
- 10 (a) "Autonomous" means a separate and distinct
- 11 operational entity which functions under its own administration
- 12 and bylaws, either within or independently of a parent
- 13 organization.
- 14 (b) "Department" means the Mississippi Department of
- 15 Health.
- 16 (c) "Freestanding hospice" means a hospice that is not
- 17 a part of any other type of health care provider.
- 18 (d) "Hospice" means an autonomous, centrally
- 19 administered, nonprofit or profit, medically directed,
- 20 nurse-coordinated program providing a continuum of home,
- 21 outpatient and homelike inpatient care for not less than four (4)
- 22 terminally ill patients and their families. It employs a hospice
- 23 care team to assist in providing palliative and supportive care to
- 24 meet the special needs arising out of the physical, emotional,
- 25 spiritual, social and economic stresses which are experienced
- 26 during the final stages of illness and during dying and
- 27 bereavement. This care is available twenty-four (24) hours a day,

- 28 seven (7) days a week, and is provided on the basis of need
- 29 regardless of inability to pay.
- 30 (e) "Hospice care team" means an interdisciplinary team
- 31 which is a working unit composed by the integration of the various
- 32 helping professions and lay persons providing hospice care. Such
- 33 team shall, as a minimum, consist of a licensed physician, a
- 34 registered nurse, a social worker, a member of the clergy or a
- 35 counselor and volunteers.
- 36 (f) "Hospice services" means items and services
- 37 furnished to an individual by a hospice, or by others under
- 38 arrangements with such a hospice program.
- 39 (g) "Medically directed" means that the delivery of
- 40 medical care is directed by a licensed physician who is employed
- 41 by the hospice for the purpose of providing ongoing palliative
- 42 care as a participating care giver on the hospice care team.
- (h) "Palliative care" means the reduction or abatement
- 44 of pain and other troubling symptoms by appropriate coordination
- 45 of all elements of the hospice care team needed to achieve needed
- 46 relief of distress.
- 47 (i) "Patient" means the terminally ill individual
- 48 receiving hospice services.
- 49 (j) "Person" means an individual, a trust or estate,
- 50 partnership, corporation, association, the state, or a political
- 51 subdivision or agency of the state.
- 52 (k) "Terminally ill" refers to a medical prognosis of
- 53 limited expected survival, of six (6) months or less at the time
- 54 of referral to a hospice, of an individual who is experiencing an
- 55 illness for which therapeutic strategies directed toward cure and
- 56 control of the disease alone outside the context of symptom
- 57 control are no longer appropriate.
- 58 **SECTION 2.** Section 41-85-7, Mississippi Code of 1972, is
- 59 amended as follows:

- 60 41-85-7. The administration of this chapter is vested in the
- 61 Mississippi Department of Health, which shall:
- 62 (a) Prepare and furnish all forms necessary under the
- 63 provisions of this chapter in relation to applications for
- 64 licensure or renewals thereof;
- (b) Collect in advance at the time of filing an
- 66 application for a license or at the time of renewal of a license a
- 67 fee of Five Hundred Dollars (\$500.00);
- 68 (c) Conduct \* \* \* inspections of hospice facilities at
- 69 such intervals as the licensing agency may direct, which may be
- 70 the same inspection as the annual Medicare certification
- 71 inspection; and
- 72 (d) Promulgate applicable rules and standards in
- 73 furtherance of the purpose of this chapter and may amend such
- 74 rules as may be necessary. The rules shall include, but not be
- 75 limited to, the following:
- 76 (i) The qualifications of professional and
- 77 ancillary personnel in order to adequately furnish hospice care;
- 78 (ii) Standards for the organization and quality of
- 79 patient care;
- 80 (iii) Procedures for maintaining records; and
- 81 (iv) Provision for the inpatient component of
- 82 hospice care and for other professional and ancillary hospice
- 83 services.
- 84 **SECTION 3.** This act shall take effect and be in force from
- 85 and after July 1, 2006.
