HOUSE BILL NO. 1179

1 AN ACT TO DIRECT THE MISSISSIPPI DEVELOPMENT AUTHORITY TO 2 EXPEND COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FUNDS APPROPRIATED 3 FOR THE HURRICANE KATRINA DISASTER FOR CERTAIN PURPOSES; TO DIRECT 4 THE DEPARTMENT OF FINANCE AND ADMINISTRATION TO DEPOSIT CDBG GRANT 5 FUNDS RECEIVED FROM THE FEDERAL GOVERNMENT INTO A SPECIAL FUND TO 6 BE EXPENDED BY THE MISSISSIPPI DEVELOPMENT AUTHORITY ONLY FOR SUCH 7 PURPOSES; AND FOR RELATED PURPOSES.

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 9 <u>SECTION 1.</u> (1) The Mississippi Development Authority shall 10 expend the federal Community Development Block Grant (CDBG) funds 11 appropriated by the United States Congress as part of the fiscal 12 year 2006 Department of Defense Appropriations Act (H.R. 2863) for 13 the following programs and purposes:

14 (a) Take advantage of the Low-Income Housing Tax
15 Credits funds through gap financing by allocating One Hundred
16 Fifty Million Dollars (\$150,000,000.00) in CDBG funds that support
17 rental housing affordable to households with incomes below sixty
18 percent (60%) of the area median income with allocation
19 preferences for projects where the units are available to
20 households at lower income levels.

(b) Be allocated to assist small rental propertyowners, as well as homeowners, outside the flood plain.

(c) Be allocated to help low-income households bridge the gap between the funds they will receive as assistance for living outside the federally designated flood plain and the cost of rebuilding their homes to the new building standards required by the Governor's proposed plan.

(d) Be allocated to rehabilitate public housing with
minimal damage to quickly make these units available to evacuees
in hotels or other unsuitable or unsustainable arrangements.

31 (e) Be allocated to allow renters to become homeowners.
32 (f) Be allocated to support educational facilities and
33 community centers such as libraries.

34 (g) Be allocated to other affordable housing programs
35 identified in the report by the Governor's Commission for
36 Recovery, Rebuilding and Renewal.

37 (2) The Department of Finance and Administration is directed
38 to deposit such CDBG grant funds received from the federal
39 government into a special fund hereby created in the State
40 Treasury to be expended by the Mississippi Development Authority
41 only for the programs and purposes enumerated in subsection (1).
