- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 5
- SECTION 1. Section 45-33-25, Mississippi Code of 1972, is 6
- 7 amended as follows:
- 8 45-33-25. (1) Any person residing in this state who has
- 9 been convicted of any sex offense or attempted sex offense or who
- 10 has been acquitted by reason of insanity for any sex offense or
- attempted sex offense or twice adjudicated delinquent for any sex 11
- offense or attempted sex offense shall register with the 12
- Mississippi Department of Public Safety. Registration shall not 13
- be required for an offense that is not a registrable sex offense. 14
- The department shall provide the initial registration information 15
- 16 as well as every change of address to the sheriff of the county of
- 17 the residence address of the registrant through either written
- notice, electronic or telephone transmissions, or online access to 18
- 19 registration information. Further, the department shall provide
- this information to the Federal Bureau of Investigation. 20
- 21 Additionally, upon notification by the registrant that he intends
- to reside outside the State of Mississippi, the department shall 22
- 23 notify the appropriate state law enforcement agency of any state
- to which a registrant is moving or has moved. 24
- (2) Any person required to register under this chapter shall 25
- 26 submit the following information at the time of registration:

- SECTION 2. Section 45-35-3, Mississippi Code of 1972, is
- 67 amended as follows:
- 68 45-35-3. (1) Any person six (6) years of age or older may
- 69 be issued an identification card by the department which is
- 70 certified by the registrant and attested by the commissioner as to
- 71 true name, correct age and such other identifying data as required
- 72 by Section 45-35-5.
- 73 (2) Whenever the department issues or renews an
- 74 identification card to an individual with a duty to register as a
- 75 sex offender pursuant to Section 45-33-25, the identification card
- 76 shall bear a designation that identifies the care holder as a
- 77 criminal sex offender.
- 78 (3) Identification cards issued to an individual with a duty
- 79 to register as a sex offender pursuant to Section 45-33-25, shall
- 80 bear a designation that identifies the card holder as a criminal
- 81 sex offender.
- 82 **SECTION 3.** Section 63-1-35, Mississippi Code of 1972, is
- 83 amended as follows:
- 84 63-1-35. (1) The Commissioner of Public Safety shall
- 85 prescribe the form of licenses issued pursuant to this article
- 86 which shall, among other features, include a driver's license
- 87 number assigned by the Department of Public Safety which, at the
- 88 option of the licensee, may or may not be the social security
- 89 number of the licensee. A licensee who chooses not to use his
- 90 social security number as his driver's license number, except as
- 91 otherwise provided under subsection (2) of this section, shall
- 92 list his social security number with the department which shall
- 93 cross reference the social security number with the driver's
- 94 license number for purposes of identification. Additionally, each

- 95 license shall bear a full face color photograph of the licensee in
- 96 such form that the license and the photograph cannot be separated.
- 97 Such photograph shall be taken so that one (1) exposure will
- 98 photograph the applicant and the application simultaneously on the
- 99 same film. The department shall use a process in the issuance of
- 100 a license with a color photograph which shall prevent as nearly as
- 101 possible any alteration, counterfeiting, duplication,
- 102 reproduction, forging or modification of such license or the
- 103 superimposition of a photograph without ready detection. Such
- 104 photograph shall be replaced by the department at the time of
- 105 renewal. Driver licenses, including photographs appearing
- 106 thereon, may be renewed by electronic means according to rules and
- 107 regulations promulgated by the commissioner. The Department of
- 108 Public Safety may accept bank credit cards and debit cards in
- 109 payment of fees for driver license renewals that are processed by
- 110 electronic means and, if authorized by general law, may charge an
- 111 additional fee for the use of such cards.
- 112 (2) The commissioner shall prescribe the form of licenses
- 113 issued pursuant to this article to licensees who are not United
- 114 States citizens and who do not possess a social security number
- 115 issued by the United States government. The licenses of such
- 116 persons shall include a number and/or other identifying features.
- 117 (3) Driver's licenses, driving permits, intermediate
- 118 licenses and commercial driver's licenses issued to an individual
- 119 with a duty to register as a sex offender pursuant to Section
- 120 45-33-25 shall bear a designation that identifies the licensee as
- 121 a criminal sex offender.
- 122 **SECTION 4.** This act shall take effect and be in force from
- 123 and after July 1, 2006.
