4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:		
5	SECTION 1. The following sum, or so much thereof as may be		
6	necessary, is hereby appropriated out of any money in any special		
7	fund in the State Treasury to the credit of the Mississippi		
8	Department of Insurance which is comprised of special source funds		
9	collected by or otherwise available to the department, for the		
10	purpose of defraying the expenses of the department for the fiscal		
11	year beginning July 1, 2006, and ending June 30, 2007		
12	\$ 7,769,621.00.		
13	SECTION 2. Of the funds appropriated under the provisions of		
14	Section 1, not more than the amounts set forth below shall be		
15	expended for the respective major objects or purposes of		
16	expenditure:

52	If, at the time the ag	ency takes any action to change "Personal

- Any transfers or escalations shall be made in accordance with

- 65 Department of Finance and Administration shall not provide written
- 66 approval to escalate any funds for salaries and/or positions
- 67 without proof of availability of new or additional funds above the

- No general funds authorized to be expended herein shall be
- 70 used to replace federal funds and/or other special funds which are
- 71 being used for salaries authorized under the provisions of this
- 72 act and which are withdrawn and no longer available.
- 73 **SECTION 3.** It is the intention of the Legislature that the
- 74 Mississippi Department of Insurance shall maintain complete
- 75 accounting and personnel records related to the expenditure of all
- 76 funds appropriated under this act and that such records shall be
- 77 in the same format and level of detail as maintained for Fiscal
- 78 Year 2006. It is further the intention of the Legislature that
- 79 the agency's budget request for Fiscal Year 2008 shall be
- 80 submitted to the Joint Legislative Budget Committee in a format
- 81 and level of detail comparable to the format and level of detail
- 82 provided during the Fiscal Year 2007 budget request process.
- 83 **SECTION 4.** Of the funds appropriated under the provisions of
- 84 Section 1, and authorized for expenditure in Section 2, Fifteen
- 85 Thousand Seventy-nine Dollars (\$15,079.00) is provided for the
- 86 Mississippi Fire Personnel Minimum Standards and Certification
- 87 Board.
- 88 **SECTION 5.** The following sum, or so much thereof as may be
- 89 necessary, is hereby appropriated out of any money in the special
- 90 fund in the State Treasury to the credit of the Rural Fire Truck
- 91 Acquisition Fund to the Mississippi Department of Insurance for

92	the Rural Fire Truck Acquisition Assistance Program for the fiscal		
93	year beginning July 1, 2006, and ending June 30, 2007

95	SECTION 6. The following sum, or so much thereof as may be		
96	necessary, is hereby appropriated out of any money in the special		
97	fund in the State Treasury to the credit of the Supplemental Rural		
98	Fire Truck Fund, created in Section 1, Laws of 2004, Third		
99	Extraordinary Session, to the Mississippi Department of Insurance		
100	for the Supplemental Rural Fire Truck Acquisition Assistance		
101	Program for the fiscal year beginning July 1, 2006, and ending		
102	June 30, 2007 \$ 2,600,000.00		
103	SECTION 7. Of the funds appropriated under the provisions of		
104	Section 1 and authorized for expenditure in Section 2, funds in		
105	the amount of Ten Thousand Dollars (\$10,000.00) are provided and		
106	shall be expended to pay the annual dues for the National		
107	Conference of Insurance Legislators.		
108	SECTION 8. It is the intention of the Legislature that none		
109	of the funds appropriated above shall be expended unless members		
110	of the Mississippi House of Representatives and Mississippi Senate		
111	are notified at least five (5) days prior to a public ceremony		
112	announcing the award of any grant in their district or any public		
113	announcement or ceremony regarding the groundbreaking or opening		
114	of a facility, roadway or bridge for which the Legislature has		
115	made funds available. Any signage regarding any public event or		
116	any new facility, roadway or bridge shall include the following		
117	language: "Funds were made available for this project by the		
118	Mississippi State Legislature."		
119	SECTION 9. It is the intention of the Legislature that		
120	whenever two (2) or more bids are received by this agency for the		
121	purchase of commodities or equipment, and whenever all things		
122	stated in such received bids are equal with respect to price,		
123	quality and service, the Mississippi Industries for the Blind		
124	shall be given preference. A similar preference shall be given to

SECTION 10. The money herein appropriated shall be paid by the State Treasurer out of any money in the State Treasury to the credit of the proper fund or funds as set forth in this act, upon warrants issued by the State Fiscal Officer; and the State Fiscal Officer shall issue his warrants upon requisitions signed by the proper person, officer or officers, in the manner provided by law.

SECTION 11. This act shall take effect and be in force from and after July 1, 2006.
