HOUSE BILL NO. 1589

1 AN ACT APPROVING THE EXPENDITURE OF SPECIAL FUNDS FOR THE
2 PURPOSE OF DEFRAYING THE EXPENSES OF THE PEARL RIVER VALLEY WATER
3 SUPPLY DISTRICT FOR THE FISCAL YEAR 2007.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

5 **SECTION 1.** The following sum, or so much thereof as may be
6 necessary, is hereby authorized and approved for expenditure out
7 of any funds which are received by or otherwise become available
8 to the Pearl River Valley Water Supply District, for the purpose
9 of defraying the expenses of the district for the fiscal year
10 beginning July 1, 2006, and ending June 30, 2007.....
11 \$ 15,111,211.00.

12 **SECTION 2.** Of the funds appropriated under the provisions of
13 Section 1, not more than the amounts set forth below shall be
14 expended for the respective major objects or purposes of
15 expenditure:

32 For the fiscal year beginning on July 1, 2006, funds are
33 provided herein to adjust the annual compensation of each employee
34 who has been employed for twelve (12) months or longer by an
35 amount equal to One Thousand Dollars (\$1,000.00), effective on
36 July 1, 2006.

37 With the funds herein appropriated, it is the intention of
38 the Legislature that it shall be the agency's responsibility to
39 make certain that funds required to be appropriated for "Personal
40 Services" for Fiscal Year 2008 do not exceed Fiscal Year 2007
41 funds appropriated for that purpose, unless programs or positions
42 are added to the agency's Fiscal Year 2008 budget by the
43 Mississippi Legislature. Based on data provided by the
44 Legislative Budget Office, the State Personnel Board shall
45 determine and publish the projected annual cost to fully fund all
46 appropriated positions in compliance with the provisions of this
47 act. It shall be the responsibility of the agency head to insure
48 that no single personnel action increases this projected annual
49 cost and/or the Fiscal Year 2007 appropriation for "Personal
50 Services" when annualized, with the exception of escalated funds.
51 If, at the time the agency takes any action to change "Personal
52 Services," the State Personnel Board determines that the agency
53 has taken an action which would cause the agency to exceed this
54 projected annual cost or the Fiscal Year 2007 "Personal Services"
55 appropriated level, when annualized, then only those actions which
56 reduce the projected annual cost and/or the appropriation
57 requirement will be processed by the State Personnel Board until
58 such time as the requirements of this provision are met.

59 Any transfers or escalations shall be made in accordance with
60 the terms, conditions and procedures established by law or

61 allowable under the terms set forth within this act. The State
62 Personnel Board shall not escalate positions without written
63 approval from the Department of Finance and Administration. The
64 Department of Finance and Administration shall not provide written
65 approval to escalate any funds for salaries and/or positions
66 without proof of availability of new or additional funds above the
67 appropriated level.

68 No general funds authorized to be expended herein shall be
69 used to replace federal funds and/or other special funds which are
70 being used for salaries authorized under the provisions of this
71 act and which are withdrawn and no longer available.

72 With the funds herein appropriated, funds are included and
73 authorized in the Salaries, Wages and Fringe Benefits major object
74 of expenditure to pay "call back pay" in lieu of "compensatory
75 time credit," at the discretion of the Director of the Pearl River
76 Valley Water Supply District, to any employee who must work on a
77 statutory holiday or any holiday proclaimed by the Governor.

78 **SECTION 3.** It is the intention of the Legislature that the
79 Pearl River Valley Water Supply District shall maintain complete
80 accounting and personnel records related to the expenditure of all
81 funds appropriated under this act and that such records shall be
82 in the same format and level of detail as maintained for Fiscal
83 Year 2006. It is further the intention of the Legislature that
84 the agency's budget request for Fiscal Year 2008 shall be
85 submitted to the Joint Legislative Budget Committee in a format
86 and level of detail comparable to the format and level of detail
87 provided during the Fiscal Year 2007 budget request process.

88 **SECTION 4.** It is the intention of the Legislature that
89 whenever two (2) or more bids are received by this agency for the
90 purchase of commodities or equipment, and whenever all things
91 stated in such received bids are equal with respect to price,
92 quality and service, the Mississippi Industries for the Blind
93 shall be given preference. A similar preference shall be given to

94 the Mississippi Industries for the Blind whenever purchases are
95 made without competitive bids.

96 **SECTION 5.** The funds herein approved for expenditure, except
97 and less an amount approved by the State Fiscal Officer which
98 shall be sufficient to cover disbursements for current operations,
99 shall be deposited at interest with any official depository of the
100 state at a rate of interest numerically not less than one percent
101 (1%) below the bank discount rate on United States Treasury bills
102 of comparable maturity as determined by the State Treasurer.

103 **SECTION 6.** The money herein approved for expenditure shall
104 be disbursed upon bank checks signed by the proper person, officer
105 or officers, in the manner provided by law or in accordance with
106 the provisions of a valid trust indenture.

107 **SECTION 7.** This act shall take effect and be in force from
108 and after July 1, 2006.
