- 95 warrants issued by the State Fiscal Officer; and the State Fiscal 96 Officer shall issue his warrants upon requisitions signed by the
- 97 proper person, officer or officers, in the manner provided by law.
- 98 **SECTION 6.** This act shall take effect and be in force from
- 99 and after July 1, 2006.
