4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:			
5	SECTION 1. The following sum, or so much thereof as may be			
6	necessary, is hereby appropriated out of any money in the State			
7	Treasury to the credit of the Oil and Gas Conservation Fund, for			
8	the purpose of defraying the expenses of the State Oil and Gas			
9	Board for the fiscal year beginning July 1, 2006, and ending			
10	June 30, 2007\$ 1,957,868.00.			
11	SECTION 2. Of the funds appropriated under the provisions of			
12	Section 1, not more than the amounts set forth below shall be			
13	expended for the respective major objects or purposes of			
14	expenditure:

31	For the fiscal	year beginning on July 1,	2006, funds are	
32	provided herein to adjust the annual compensation of each employee			
33	who has been employed for twelve (12) months or longer by an			
34	amount equal to One Thousand Dollars (\$1,000.00), effective on			
35	July 1, 2006.			
36	With the funds herein appropriated, it is the intention of			
37	the Legislature that it shall be the agency's responsibility to			
38	make certain that funds required to be appropriated for "Personal			
39	Services" for Fiscal Year 2008 do not exceed Fiscal Year 2007			
40	funds appropriated for that purpose, unless programs or positions			
41	are added to the agency's Fiscal Year 2008 budget by the			
42	Mississippi Legislature. Based on data provided by the			
43	Legislative Budget Office, the State Personnel Board shall			
44	determine and publish the projected annual cost to fully fund all			
45	appropriated positions in compliance with the provisions of this			
46	act. It shall be the responsibility of the agency head to insure			
47	that no single personnel action increases this projected annual			
48	cost and/or the Fiscal Year 2007 appropriation for "Personal			
49	Services" when annualized, with the exception of escalated funds.			
50	If, at the time the agency takes any action to change "Personal			
51	Services," the State Personnel Board determines that the agency			
52	has taken an action	which would cause the agen-	cy to exceed this	
53	projected annual cost or the Fiscal Year 2007 "Personal Services"			
54	appropriated level, when annualized, then only those actions which			
55	reduce the projected annual cost and/or the appropriation			
56	requirement will be processed by the State Personnel Board until			
57	such time as the req	uirements of this provision	n are met.	
58	Any transfers o	r escalations shall be made	e in accordance with	
59	the terms, condition	s and procedures establish	ed by law or

- 61 Personnel Board shall not escalate positions without written
- 62 approval from the Department of Finance and Administration. The
- 63 Department of Finance and Administration shall not provide written
- 64 approval to escalate any funds for salaries and/or positions
- 65 without proof of availability of new or additional funds above the
- 66 appropriated level.
- No general funds authorized to be expended herein shall be
- 68 used to replace federal funds and/or other special funds which are
- 69 being used for salaries authorized under the provisions of this
- 70 act and which are withdrawn and no longer available.
- 71 **SECTION 3.** It is the intention of the Legislature that the
- 72 State Oil and Gas Board shall maintain complete accounting and
- 73 personnel records related to the expenditure of all funds
- 74 appropriated under this act and that such records shall be in the
- 75 same format and level of detail as maintained for Fiscal Year
- 76 2006. It is further the intention of the Legislature that the
- 77 agency's budget request for Fiscal Year 2008 shall be submitted to
- 78 the Joint Legislative Budget Committee in a format and level of
- 79 detail comparable to the format and level of detail provided
- 80 during the Fiscal Year 2007 budget request process.
- 81 **SECTION 4.** With the funds provided herein, it is the
- 82 intention of the Legislature that the State Oil and Gas Board
- 83 purchase liability insurance.
- 84 **SECTION 5.** It is the intention of the Legislature that
- 85 whenever two (2) or more bids are received by this agency for the
- 86 purchase of commodities or equipment, and whenever all things
- 87 stated in such received bids are equal with respect to price,
- 88 quality and service, the Mississippi Industries for the Blind
- 89 shall be given preference. A similar preference shall be given to
- 90 the Mississippi Industries for the Blind whenever purchases are
- 91 made without competitive bids.
- 92 **SECTION 6.** The money herein appropriated shall be paid by
- 93 the State Treasurer out of any money in the State Treasury to the

credit of the proper fund or funds as set forth in this act, upon warrants issued by the State Fiscal Officer; and the State Fiscal Officer shall issue his warrants upon requisitions signed by the proper person, officer or officers, in the manner provided by law. SECTION 7. This act shall take effect and be in force from
